 - a. February, 2015. NJLINCS Health Alert Network Update. RE: Suspect Measles Case - Mercer County
The New Jersey Department of Health (NJDOH) Vaccine Preventable Disease Program, in collaboration with the Princeton Health Department and Princeton University, is investigating a suspect case of measles in a Princeton University undergraduate student with rash onset February 8, 2015. At this time, there is no identified connection to the ongoing measles outbreak associated with Disneyland in California or with the case of measles recently identified in Hudson County, NJ. Exposures potentially occurred on the Princeton University campus.  - b. March, 2015. NJLINCS Health Alert Network Update. Re: The Pet Store Disclosure Act. Senate Bill S-1870, “The Pet Store Disclosure Bill” was signed into law on February 5, 2015 and codified as N.J.S.A. 56:8-92 through 95.3. This law establishes additional requirements under the Department of Law and Public Safety, Division of Consumer Affairs for all pet shops or pet dealers to provide breeder information to consumers about each cat or dog being offered for sale. The bill requires this information to be posted on each cage or enclosure in a pet shop and in internet and print advertisements.
