Only area to work with is main area close to entrance. Would be able to do, but would be a short trail. Belleplain has room for 10 miles of trail. Steve has spoken with some residents who are interested in getting involved

Steve has spoken with Julia Karavan, a new Assoc. Professor with Rutgers Extension about having the Farmers Market at the 4H Fair Grounds over by the college. She is making a presentation on the Farmers Market next Monday, August 26<sup>th</sup> at 7:30 at the Rutgers Extension Office if any EC members would like to attend. Steve said having hard time finding a place where wine vendors can sell their product. He said in Cumberland County the wine vendors can come and display their products, but were not allowed to be opened or sold at the market. Rachel Shepherd suggested getting sponsors for the market. She said Sturdy helps sponsor the West Cape May Market. Steve said we are in need of crafters. He is going to look into getting sponsors.
