THIS MEETING IS BEING RECORDED:

I hereby declare that notice has been given to the Herald Times, the Atlantic City Press and posted on the bulletin board of the Middle Township Municipal Building, stating the time and place of the following meeting, as required in P.L. 1975, Chapter 231 of the State of New Jersey. (Sunshine Law).

The Township Committee met on the above date at 6:00 PM at the Middle Township Municipal Building. Members present were Mayor Lockwood, Committeemember Donohue, Committeemember DeLanzo, Township Business Administrator Mark Mallett, Township Clerk Kimberly Krauss, Municipal Solicitor Dotsie Garrabrant, and Township Engineer Marc DeBlasio

1. QUESTION/ANSWER PERIOD ON AGENDA (This question and answer session shall relate only to items as outlined and pending on current agenda. Issues and concerns not related to agenda item shall be withheld to public comment portion at the conclusion of meeting.)

Carol Mattessich asked if item #6 is the annual ordinance. Asked for descriptions on potential litigation(item #9) . #21 Why needed and have we used this person in the past?

Kim Krauss indicated that #6 is indeed the annual salary ordinance. Mrs. Garrabrant indicated that when the resolution is read the title is going to be amended and descriptions will be given at that time.

Dotsie Garrabrant /Mayor Lockwood stated that #21 is in order to deal with issues pending and it has been suggested that the township enter into an agreement with this professional for his expertise. He has not worked with twp. before.

Carol Mattessich #22 – bill items written to A& H ... did research after speaking to Mr. Mallett and DEP have come up with 2 concerns and reasons to hold payments to this company.

1. *Class B recycling - A&H is not a class b licensed entity, one of their companies are, however A&H is not... careful who you write your checks to. Future Mining is the class b recycler. DEP contact is Vince McDermott (contact phone numbers provided).*
2. *DEP Compliance Division has indicated that the only A & H mining pit that is licensed with the state is one in Maurice River Twp. Whatever the twp. is buying make sure the pit is licensed since previous employees of A&H have expressed contamination with materials at this pit.*

Mrs. Garrabrant suggested that twp. contact A&H to give them a chance to defend accusations. Commented that Ms. Mattessich has made false claims earlier this meeting regarding other non-related topics and A&H should have the opportunity to defend claims.

12. RESOLUTION NO. 103-12 – AUTHORIZING TOWNSHIP TO FURTHER EXCEED STATUTORY 60-DAY BID LIMITATION – CONTRACT AND MANAGEMENT SERVICES FOR THE TOWNSHIP OF MIDDLE, NEW JERSEY MUNICIPAL WASTEWATER SYSTEMS – On motion by Mayor Lockwood seconded by Committeemember Donohue and passed on roll call, the following resolution was adopted.
WHEREAS, it was deemed necessary and desirable to solicit for bids for management services towards the Township of Middle Municipal Wastewater System, and
WHEREAS, NJSA 40A:11-24 delegates the time table for making awards and returning deposits, and
WHEREAS, statute states that the contracting unit shall award or reject the contract in no case more than 60 days after receipt, except that the bidders who consent thereto at the request of the contracting unit, be held for consideration for such longer period as agreed, and
WHEREAS, there was language in said proposal that outlined a 90-day review timeframe for said project, in which the bidder had consented to when bidding the project, and
WHEREAS, On December 5, 2011 via Resolution 607-11 the Township of Middle authorized the extension of the statutory 60-day bid limitation for the project known as “CONTRACT AND MANAGEMENT SERVICES FOR THE TOWNSHIP OF MIDDLE, NEW JERSEY MUNICIPAL WASTEWATER SYSTEMS”, and
