# **Eastern Geosciences discussion**

Vince Orlando stated received proposal from Tom Dwyer of EGI for the Storm Water Evaluation Impact Study and we received proposal, which was higher than anticipated of a not to exceed \$10,700. Township Committee had authorized \$5000. Vince sent Tom as much information as he had and Tom is going to relook at the price to try to get it down a little. We don't have a choice but to do this. John Herzog has agreed to do whatever needs to be done. The system between Marlyn and Linden has to be replaced with a cost of somewhere between \$25,000 to \$30,000. Does not solve the whole problem, but at least gets the water to the pond. A resolution would need to be done to approve this, not to exceed \$10,700.
