Phil Broder: Said 5th Anniversary of when work began on 9th Avenue and still no resolution. Truckloads of trash dumped on their street....police said street should be blocked off past last driveway.

Jim Pickering: Builder went bankrupt and this work should not be responsibility of taxpayers. Have money in a bond to finish work. Plans are for drainage and to finish road work, that will finish the project.
