ORDINANCE NO. 1360-10 - AN ORDINANCE OF THE TOWNSHIP OF MIDDLE, COUNTY OF CAPE MAY, NEW JERSEY, APPROPRIATING THE SUM OF \$298,700 IN FUNDING FROM THE CAPITAL IMPROVEMENT FUND FOR POLICE, WHITESBORO SCHOOL, AND TOWN HALL IMPROVEMENTS

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MIDDLE, COUNTY OF CAPE MAY, STATE OF NEW JERSEY, AS FOLLOWS: Section 1. There is hereby appropriated the sum of \$298,700 from the

Capital Improvement Fund of the Township of Middle, County of Cape May, New Jersey ("Township") for:

Section 2. It is hereby determined and stated that the improvements set forth in Section 1 are each a general capital

improvement and not a current expense.

<u>Section 3.</u> The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

Section 4. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency. Section 5. This ordinance shall take effect after final adoption and publication as required by law.

ORDINANCE NO. 1361-10 - AN ORDINANCE OF THE TOWNSHIP OF MIDDLE, COUNTY OF CAPE MAY AND STATE OF NEW JERSEY TO AMEND CHAPTER 158 SECTION 15 OF THE TOWNSHIP CODE REGARDING SPECIAL PICKUP OF BULK TRASH

BE IT ORDAINED, by the Township Committee of the Township of Middle in the County of Cape May and State of New Jersey as follows: SECTION 1. Chapter 158 Section 15 of the Code of the Township of Middle is hereby deleted and replaced by the following:

- The collection, removal and disposal of bulk trash shall be made by the township or its contractor pursuant to policies and a schedule periodically established by resolution approved by the Township Committee.
 - B. Each property owner shall place no more than one bulk trash item at curbside per month.
 - C. The property owner shall place the bulk trash item at the curb no earlier than 24 hours before the scheduled collection date.

SECTION 2. All other ordinances in conflict or inconsistent with

are hereby repealed, to the extent of such conflict or inconsistency SECTION 3. Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this ordinance shall not be affected thereby and shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION 4. This ordinance shall become effective immediately upon final passage and

publication, according to law.
