12. RESOLUTION NO. 113-09 – RATIFY SHARED SERVICES AGREEMENT WITH COUNTY OF CAPE MAY – HISTORIC DOCUMENT CONSERVATION CONTRACT – PARIS GRANT – On motion by Committeemember Barry seconded by Mayor Doughty and passed on roll call, the following resolution was adopted.  
WHEREAS, the County received a Public Archives and Records Infrastructure Support (PARIS) grant, a portion of which is dedicated to the conservation of historic documents originating from the County and the Municipality; and  
WHEREAS, the Municipality has previously agreed to support the County in applying for the PARIS grant under one application in an effort to achieve economies of scale through shared services; and  
WHEREAS, the County has issued a Request for Bid SPEC #9 to select one vendor and will execute a contract with said vendor to furnish and deliver conservation treatments, preservation microfilming, and scanning for archival and historically significant document collections of the County and of the Municipality; and  
WHEREAS, the Municipality has selected historically relevant documents which are in need of the treatment described above and expressed its desire to participate with the County under a Shared Services Agreement; and  
WHEREAS, since one contract will be executed by the County with the selected vendor the County and the Municipality desire to establish and delineate their respective responsibilities with regard to the PARIS project and between each other; and  
WHEREAS, N.J.S.A. 40A:65-1, et seq. authorizes local government units to enter into agreements for the exchange of services pursuant to the provisions of that statute known as the "Uniform Shared Services and Consolidation Act" (“Act”); and  
NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Middle, County of Cape May, State of New Jersey that the appropriate officials are hereby authorized and directed to sign said agreement.
13. RESOLUTION NO. 114-09 – AUTHORIZING POLICE DEPARTMENT TO PARTICIPATE IN “A CHILD IS MISSING ALERT PROGRAM” – On motion by Committeemember DeLanzo seconded by Committeemember Barry and passed on roll call, the following resolution was adopted.  
WHEREAS, A Child is Missing (ACIM) is a Fort Lauderdale-based non-profit organization founded in 1997, and was created because no community-based program existed for locating missing children, the disabled and elderly often (with Alzheimer's) during the crucial first hours of disappearance.  
WHEREAS, a child goes missing every 40 seconds in the United States, and  
WHEREAS, ACIM is devoted to assisting law enforcement in the search and early safe recovery efforts of children / the elderly (often with Alzheimer's) / disabled persons and college students via a rapid-response neighborhood alert program utilizing high-tech telephony systems, and  
WHEREAS, this service is free service to law enforcement.  
NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Middle, County of Cape May, State of New Jersey that authorization is hereby granted to the Police Department to participate in the “A Child is Missing” Alert Program  
BE IT FURTHER RESOLVED, that participation is a on-going unless otherwise cancelled by either party.
14. RESOLUTION NO. 115-09 – ACCEPTING ASSIGNMENT – On motion by Committeemember Barry seconded by Committeemember DeLanzo and passed on roll call, the following resolution was adopted.

WHEREAS, Eugene W. Boyd Jr of 630 W. WHEREAS, N.J.S.A.40:48-2.14 authorizes the municipality the right to place a lien against such dwelling or lands to provide for the cost of removing brush, weeds debris, etc., and  
WHEREAS, the Township of Middle has adopted Ordinance No. 316-76 known as Article I of Chapter 193 of the Code of the Township of Middle “Property Maintenance”, and  
WHEREAS, the Township of Middle has noticed the following property owners as indicated below and furthermore these violations had not been remedied.  
WHEREAS, in absence of compliance by said owners, the Township of Middle commenced and completed abatement of these violations, and  
WHEREAS, the Public Works Supervisor of the Township of Middle has certified the following cost as listed.

26. PUBLIC COMMENT:

Committeeman Steve Barry: Went to high school musical Saturday night, was amazed at how many talented students there were there and how much effort put forth to put on very professional show. Made me think about question in the Work Session, sort of sourness and hesitation to commit to young families. It was a remarkable and very enjoyable display of how the investment in young families pays off in the short and long run, so it was a spirit lifter.

Deputy Mayor Susan DeLanzo: Had something to bring up in Work Session, guesses can bring u p now. Was given potential for a grant for a new hire for police officers, the Federal Government has put this out. What was really wonderful about this is that there is no match from the local government and that it not only pays 3 years of salary, but also benefits. In the past, grants that we have gone for have been a decrease

and to my knowledge has never included the benefits. Why I would like support for this is, Lt Leusner applies for the grants, and would like to pursue this. Obviously it is not guaranteed that we would get it, but in the hopes that we might. In looking over the roles of the police department and how we will be losing officers through retirement over the next 3 years, it would be a real cost effective way of maintaining a level that is needed. I was hoping to garner your support this evening so that we can proceed with this grant application.

Mayor Doughty: Over the next 3 years, how many do we have retiring?

Steve Barry: 2 this year.

Susan DeLanzo: We could be down to 43 by 2011, this is what I see here.

Lt Leusner: Yes, don't have exact numbers, thinks losing about 7 officers in the next 2 years and it takes 8 months to replace an officer.

Steve Barry: Question about grant is, obviously every town is different in how it would pay their 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> year police officers. Does the grant just float with the town or is there a salary set in the grant.

Chief Evangelista: The grant paperwork didn't say. The grants we had in the past paid 75% , 50% and then 25% of our existing salary structure. You have to guarantee to carry them into the 4<sup>th</sup> year. This one is 100% funding for salary and benefits. It would be our intent to apply for 4 officers, doesn't know what the Township has in mind, would rather ask for a lot and only get a little . Academy starts in August, so need to apply now.

Steve Barry: Do you know when we might expect an answer.

Chief Evangelista: No, because the grant does not open up until the end of March.

Jim Pickering: These are Federal dollars, are they new Federal dollars?

Chief Evangelista: Yes, they reinstituted the cops hiring program. Under President Clinton, under President Bush it was taken away. There is some argument in the Federal Government about this 100% funding .

Jim Pickering: In 1993 or 1994 President Clinton had this bill to put 100,000 new police officers on the streets throughout America, so this is essentially refunding that same program?

Chief Evangelista: Yes, but this time it is at 100% with benefits. We did apply for those grants before.

Lt Leusner: It is also part of the stimulus package that was passed also. This is where this money is coming from.

Mayor Doughty: At the next Township meeting we will bring up what we as Township Committee are proposing for our stimulus package. In 2005 our Municipal Engineer, Vince Orlando did the parking lots and the street scape for Mechanic Street. The next meeting we will have that available and put it out here so you can see it.

Jim Pickering: If you get the funding, correct?

Steve Barry: If we don't get the funding, then we are not going to do it.

Mayor Doughty: It will be a wonderful project for downtown. We have to think positive.

Dan Lockwood: Quick comment on your comment during the VIM presentation. You had questioned someone had questioned the donation to VIM, I think it is unfair to characterize Madelyn's questioning a donation.

Mayor Doughty: I did not mention anyone's name. Can I tell you something right now, we sit here and listen to all of this stuff ....

Dan Lockwood: Can you let me finish though, it is really not that controversial, I just felt that she was questioning the authority or how the authority derives to donate Township money. I just wanted to clarify that for the record. I am not criticizing you guys, I think VIM is a great organization. I do want to make an issue about the status of the Future Mining and Recycling situation as far as both the accounting and the lawsuit. Is there any updates?

Jim Pickering: There is not any updates at this time since we discussed it at length at the last meeting.

Dan Lockwood: Are you answering for both questions.

Jim Pickering: Yes.

Dan Lockwood: So just to make sure I understand, there has been no modification how we account for the monies that are due to or coming from....

Jim Pickering: The accounting happens on a quarterly basis and I am certain before the end of this quarter that issue will be addressed.

Dan Lockwood: Who has been responsible for the omission of the baseball commissioner in the last list of salaries?

Tracey Taverner: That would be myself.

Kim Tomkinson: Clerical error.

Mayor Doughty: How many children do you have that play out there.

Dan Lockwood: The number of children that I have does not impact the baseball program and a commissioner. We have a recreational program and there were people that ran the baseball program many years before there was a baseball commissioner, with many children coming and going through it. It is a financial issue, it is not a criticism of baseball.

Larry Zamba: Just wanted the Committee to be aware of a concern that is going on in his neighborhood on Cardinal Drive. To the south of neighborhood is a farm, which was a farm for many years and is now a vineyard. The other day this farm had a party and they are now selling wine and it is now becoming a commercial business. It is directly affecting the neighborhood of Cardinal Acres. Are seeing a lot of traffic, a wide variety of cars parked back there and concerns are whether that property is a farm or a commercial property. If commercial property, it is greatly affecting their neighborhood. Just wanted Committee to be aware of concerns. Not sure if Committee was aware of what is going on and what could be done about it.

Mayor Doughty: Give Mark Mallett, Business Administrator your information and he will look into it and get back to you.

Marty Bell: Is Larry's neighbor. House is right next to the Vineyard. Moved into house in 1985, was first house built in development. Now that the Vineyard has moved in there, the access road behind her house and is a right of way to them is also part of her property. Owns half of the access road to get to the actual house in the back. The events that they are now doing back there are wine tastings, bands, DJ's, tents. The last event cars were parked everywhere behind her house, not on her property, on their property, but that is beside the point. My survey will show you this is just an access road, a one car road, not a business road. Other concern is the man is defacing her property. Believes he is trying to widen the road. Had police officer come out when for the 3<sup>rd</sup> time he was messing with her property. Moved in there 24 years ago to what was then a beautiful area, very quiet, would like to know how this all happened.

Mayor Doughty: Meeting adjourned. Going into Executive Session.

#### CAME OUT OF CLOSED SESSION

Jim Pickering: When we come out of Executive Session there likely will not be any action taken.

Jim Pickering: In the Executive Session 2 matters of potential litigation were discussed, one of them had to do with the Baker Estate and Township Committee authorized me, the Municipal Solicitor, to file an action in that matter. The other matter was to discuss bills from a vendor that appear likely to end up in litigation and myself, the CFO and the Administrator and Clerk informed the Committee of the status of that matter.

#### REGULAR SESSION:

Jim Pickering: We are back in the regular session. A matter came up with regard to a resolution that was approved to pay the bills, it appears that Mayor Doughty has been abstaining on certain votes. I suggested we have a resolution to repeal the resolution that originally paid the bills, if someone would make that motion.

Susan DeLanzo: So moved.

Steve Barry: Second

Roll Call: DeLanzo, Barry – Aye      Mayor Doughty abstained.

Jim Pickering: Let's break this up into 2 different resolutions...can we have a resolution to approve payment of all the bills except for the bill submitted by Albrecht & Heun?

Steve Barry: Then all 3 of us vote on that?

Jim Pickering: Yes.

Kim Tomkinson & Steve Barry: Or just do one and have him abstain on all.

Jim Pickering: You can do it that way.

Kim Tomkinson: That way we don't have to do 3 resolutions. So we did resolution rescinding all bills and now we are doing a resolution to approve bills.
