RESOLUTION TERMINATING PARTICIPATION UNDER THE NEW JERSEY STATE HEALTH BENEFITS PROGRAM (WHICH INCLUDES PRESCRIPTION DRUG PROGRAM AND/OR DENTAL PLAN COVERAGE) – On motion by seconded by and passed on roll call, the following resolution was adopted. ** TABLED UNTIL 4/5/2010 WHEREAS, The Township of Middle currently provides health benefits to its employees through the New Jersey State Health Benefits Program; and WHEREAS, The Township of Middle incurred a cost increase of 20% in the year 2010; and WHEREAS, it is indicated that there will be significant cost increases in 2011 and beyond; and WHEREAS, The Township of Middle has determined that it will provide the same or better health benefits to its employees through a different provider at a significant savings, NOW THEREFORE BE IT RESOLVED,
 - 1. The Township of Middle, County of Cape May, State of New Jersey hereby resolves to terminate its participation in the program (including Prescription Drug and/or Dental Plan) thereby canceling coverage provided by the New Jersey State Health Benefits Program (N.J.S.A. 52:14-17.25 et seq.) for all its active and retired employees.
 - 2. We shall notify all active employees of the date of their termination of coverage under the program.
 - 3. We understand that the Division of Pensions and Benefits will notify retired employees of the cancellation of their coverage.
 - 4. We understand that all COBRA participants will be notified by the Division of Pensions and Benefits and advised to contact our office concerning a possible alternative health, prescription drug, and dental insurance program.
 - 5. We understand that this resolution shall take affect the first of the month following a 60-day period beginning with the receipt of the resolution by the State Health Benefits Commission.

5. 2010 BUDGET DISCUSSION

Township Administrator Mark Mallett went over areas of the budget where he felt the township could save money.

Bonnie Seramellow – Thinks the township should focus more on big ticket items in reducing budget cost.

Bob Noel – said in relation to shopping carts the township should just drop them back off to the owner then bill for the drop off.

Mike Voll – thinks business registration is very important and would be very great for intelligence in policing. They would be able to keep information in their computers. There are too many shady vendors with hammers and the citizens have no recourse. We should look at Lower Township.

Committeemember Lockwood explained experience with other towns with merchant licensing and all the fees he had to pay associated with it.

Chief Leusner gave explanations of businesses where a license would have been useful.

Joe Ravitz stated that in regards to shopping carts, if the town had mercantile licensing then we would have a hammer to have businesses come and pick up their carts.

Mayor DeLanzo thinks that these ideas have merit but have to be aware of fees incurred by other entities such as fire district, and other factors that already hit them.

David May indicated that this suggestion isn't for the township to make money but to keep better control.

B. Noel – stated that he is confused as to what he is hearing. Majority of businesses do not cause discrepancies in the township. Other departments already have business information.. no need to duplicate. Let's look at the whole picture. You do know where the businesses are. To create a whole new system not to raise revenue is pointless.

Committeemember Doughty indicated that Ocean City says even if you are a contractor that is licensed through the state you still have to get a mercantile license.

M. Voll – thinks Middle needs to check with other towns to see how they do it. This would be a nice chunk of change in the budget.

Lee Ann Russ thinks \$1,500.00 is too low of a rent fee for usage of the monopole.

Elaine Fausey – FCC is not concerned with the health factors of the monopole.

Committeemember Lockwood stepped out of the meeting at 11:15am

E. Fausey – indicated that another source of revenue is dog licenses.

6. PUBLIC COMMENT:

Fran Fiore – asked of the 1.5% that township employees now have to pay towards health insurance goes towards 2010 revenue? PBA hasn't settled contract yet. Is there a difference in the options?

Jim Pickering - indicated that he will look into the bill that was passed.

Robert Matthews - asked for clarification on price to charge non-profit for use of MLK center

Chuck McDonnell – as a group we need to sit down and go over fees.

Sharon Coco- asked to see a copy of contract that township anticipates when terminating state health benefits.

Peggy Mathis – how much of cost savings to township once opt out of state health benefits. What would it be in a couple of years?

E. Fausey – applauds committee on going after little savings. Indicated that taxpayers association has been saying that for years. Asked if township will start usage of "P" card. Stated that bulk pickup should be looked at.

There being no further business the meeting was adjourned at 11:45pm.
