WHEREAS, this award is contingent upon receiving approvals through the NJ DOT pilot program for intersection safety cameras and fees to be appropriated in 2011 budget.

AMERICAN TRAFFIC SOLUTIONS (ATS) – PENDING NJ DOT APPROVAL FOR 2011 NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Middle, the governing body thereof, that the contract to design, install, operate and maintain intersection safety cameras is hereby awarded pending NJ DOT approval and no fees are to be charged to the 2010 budget.

FURTHER RESOLVED, that this award is conditioned upon submission of Treasurer's Certification of availability of funds.

15. RESOLUTION NO. 443-10 – RELEASE OF PERFORMANCE BOND – POSTING OF MAINTENANCE BOND – ACCEPTANCE OF STREET – JULIA COURT – On motion by Committeemember Lockwood seconded by Committeemember Doughty and passed on roll call, the following resolution was adopted.

WHEREAS, most improvements located at Block 94 Lot 69, otherwise known as Julia Court is complete with the exception of items as outlined by the engineer, and
