Request for Street Opening Waiver - 10 Seabreeze Lane

Marc DeBlasio:

Gave background on application submitted for street opening and waiver. Seabreeze Lane was paved in 2014 and notices to property owners and utility companies were sent/hand delivered before paving project commenced. Ownership of property changed after paving project was complete. Suggests two recommendations to Township Committee: 1) See if property owner can tap into gas main from neighboring property or 2) Consider application and waiver.
