- Committeemember DeVico:
  - Agrees with idea of videotaping meetings; gives the individuals who are unable to physically attend the opportunity to view.
- Agrees there is a lot of work to be done concerning homelessness and winter weather. Mayor Clark:
  - Not opposed to idea of videotaping meetings; thinks it would be good for transparency; cost factor.
  - Homelessness can be worked on at municipal level but also needs to be worked on at county level; winter is coming.
- Committeemember Donohue:
  - Cost factor is a concern; extra work for Clerk; first person in five years to ask for meetings to be videotaped.
  - Does not believe Middle Township can solve homelessness in Cape May County alone; best to try and manage it within borders; not an easy problem to fix if not it'd already be done. Some homeless want to be left alone; that is their choice.

Chief Leusner:

- Serves on a grant committee called Cape Regional Wellness Alliance; received a grant of \$50,000 per year to be spent over the next four years.
- Purpose of committee is building culture of health in Cape May County; didn't realize the related challenges and obstacles.
- Training for four days; spoke of homelessness and mental health, substance abuse, etc.
- We have seen some progress.

Committeemember Donohue:

- Has discussed issue with Chief Leusner; not a fan.
- Unfunded mandate.
- *Restated comment Chief Leusner made regarding having a higher tolerance towards non-violent repetitive offenders.*
- Sees it as unfavorable for many organizations.

Chief Leusner:

- Largest change in criminal justice system since 1947; requires a huge shift in thinking.
  A lot is going to rest on technology.
- Rosie Jefferson, Cape May Court House:
  - Thanked Connie Mahon for her service.

Mayor Clark:

- Attended "Lights on After School Program," at the MLK center.
- Black and Orange fundraiser for new score board; junior football league.
- Committee attended Retirement Flag Burning Ceremony for the DAV at the park in Del Haven.
- Successful Halloween parade; judging was held in front of the Belleview.
- Commended Rec staff and Public Works for cleaning the streets; and police officers for helping keep things in order.
