ORDINANCE 1521-16 AN ORDINANCE ESTABLISHING THE COMPENSATION OF THE OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF MIDDLE Following second reading, hearing, and consideration for adoption, Ordinance 1521-16 was adopted on motion by Committeemember Donohue seconded by Committeemember DeVico and passed on roll call. Complete Ordinance is on file in the Clerk's Office.

BE IT ORDAINED by the Township Committee, the Governing Body of the Township of Middle, County of Cape May, State of New Jersey as follows:

SECTION 1. The positions listed in the attached schedule are hereby created.

SECTION 2. The salary ranges specified in the attached schedule are hereby adopted for each and every position listed therein. In those cases where only one rate or figure appears in said schedule, said rate or figure shall be the maximum rate of figure applicable to said position. In those cases where a maximum and minimum salary are hereby established for a position, the exact salary to be paid to the holder of said position shall be as determined from time to time by resolution of the Township Committee.

SECTION 3. The duties to be performed by each person holding any position listed in said schedule shall be those duties as outlined in Job Description of New Jersey Civil Service Department.

SECTION 4. In addition to the salaries set forth in said schedule, those employees who have held full time positions for a minimum of five years, as hereinafter defined, shall be entitled to additional compensation as set forth in this section, based upon current salary. The additional compensation to which the employee is entitled on January 1 of any year shall be the additional compensation for the entire year. In determining years of service on January 1 of any year, for the purpose of this Ordinance only, no credit shall be given for less than six full months of service in any year, and credit for a full year shall be given for any year in which the employee served for six full months or more.

Section 4 shall only apply to Township Employees hired before December 31, 1994. SECTION 5. All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

SECTION 6. This Ordinance shall become effective, retroactive to January 1, 2016 immediately upon final passage and publication according to law.

WHEREAS, there exists a memorandum of understanding which currently remains in the hands of the Department of Human Services and is yet to be approved, all while the homeless population of Cape May County continues to be placed in local motels with no on-site job training or counseling; and

WHEREAS; the Atlantic City Rescue Mission works with over 50 agencies to provide job training, drug and alcohol counseling, spiritual counseling, life skills training and provides a safe and secure temporary housing environment for those in need; and

WHEREAS, it is statistically proven that counseling and job training are necessary to break the cycle of homelessness; and

WHEREAS, the increasing homeless population in Cape May County deserves access to a better life through counseling and training.

NOW THEREFORE BE IT RESOLVED, by the governing body of the Township of Middle, County of Cape May, State of New Jersey, that the membership of the Cape May County League of Municipalities hereby supports the use of the Atlantic City Rescue Mission to temporarily house homeless individuals and further urges the Department of Human Services to approve the memorandum of understanding between the County of Cape May and the Atlantic City Rescue Mission

WHEREAS, the Township of Middle Office of Emergency Management, designated by the New Jersey State Police, Office of Emergency Management, has submitted an Application for the subaward that has been required by the said New Jersey State Police Office of Emergency Management; and

WHEREAS, the Application for the sub-award calls for a match in the amount of \$7,000.00, which the Township of Middle, Office of Emergency Management will satisfy through the 2016 Township of Middle approved budget for Division salaries and wages and fringe benefits. NOW, THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Middle hereby authorizes the application for the award of the FY 2015 Emergency Management Performance Grant in the amount of \$7,000.00 Federal Funds from the New Jersey State Police, Office of Emergency Management; and

BE IT FURTHER RESOLVED that the Director of the Division of Local Government Services is requested to approve the insertion of an item of revenue in the budget of the year 2016 in the sum of \$7,000.00, once approved, from the New Jersey State Police, Office of Emergency Management in the like amount of \$7,000.00 from the aforementioned grant; and BE IT FURTHER RESOLVED that the like sum of \$7,000.00 is hereby appropriated under the caption FY 2015 Emergency Management Performance Grant; and BE IT FURTHER RESOLVED that the Mayor, Chief Financial Officer and the Township Emergency Management Coordinator are authorized to sign the appropriate sub-award documents;

23. PUBLIC COMMENT:

John Larcella- would like to see an advertisement in a newspaper up north, like the Star Ledger, advertising Middle Township and our tourism in order to increase to our ratables.

Committeeman Donohue spoke of the Permit Extension Act expiration and the pick-up in activity in our Construction and Zoning Departments. The Township is seeing revenue double in our Construction Department.

William Lane, Avalon Manor – expressed that there is a buildup of seagrass in his area from the last storm. The utility trucks are putting up new poles and spreading the grass back out into the roadways. Would like to have PW come back out to clean it up.

Edith Boyd – expressed concern regarding Gibbs Street and the need to repave the road. Indicated that it is constantly patched up and is in "terrible condition." She also asked that the committee look into putting street lights in the area. Ms. Boyd asked what the income requirement was for the housing complexes in Rio Grande and Court House.

Connie – spoke of the "work force housing" complexes and the income requirements (minimum and maximum incomes) as well as the background checks conducted by the developer.

Committeeman Donohue gave some background information on the Conifer management group and indicated that a resident needs to apply to the housing management group for more information.

E. Boyd spoke of the problems faced by those men and women that return from overseas.

Dan Lockwood, CMCH – expressed that he felt there was lack of budget information being introduced at the meeting. He indicated that the CFO made a comment about a "zero percent" increase so he thought the budget was prepared.

Committeeman DeVico informed Mr. Lockwood of the public hearing scheduled for 03/21 work session and also the intent to introduce the budget at the regular meeting scheduled that same night.

D. Lockwood asked if the budget will be available to the public prior to introduction.

Mayor Clark indicated that it is a working document subject to change but will look into making it available to the public ahead of time.

D. Lockwood commented on the hard work of the past administration to keep the budget at a zero percent increase. Voiced concern with being too aggressive with line items or doing things with lines where you would throw expense lines over the cap. "Would be very weary to do things that can't be ironed out in future years, or to put yourself in a corner with the budget."

Mayor Clark - We have held the line, came in with a zero margin, we have had increases in revenue in construction office...

D. Lockwood commented on construction fees by saying, "if you are too aggressive there then that too would be dangerous because you haven't had a full year of construction fees. He also commented on the reduction in the fuel line and other expense lines. He continued to comment on decisions made when he was on Township Committee regarding the budget which helped keep the budget at a zero percent tax increase.

Committeeman Donohue commented that he and committee have seen the working document and he has expressed concerns that he has with the budget. He spoke of the change on committee, the new CFO and also the new auditor. He believes that "yes, Committee will get to zero" but questions whether or not the auditor understands the long term planning that the previous administration had in place. Commented that he has yet to meet the auditor and it is already March. Spoke of shifting of cost into the sewer department for the tax collector salaries and also spoke of other concerns regarding some of the other line items. Stated that the budget needs work wanted to make sure that township is maintaining the integrity of the changes that were built into the budget to "bend the cost of government down in the long run not just year to year." Would like to have something available to the public ahead of upcoming work session presentation.

Mayor Clark commented on the hard work of John, Connie and the auditors in this process. Commented that if Committeeman Donohue wants to meet auditors that they would meet with him.

Committeeman DeVico commented on the number of times he has met with auditors and apologized for the lack of communication with Tim and the auditors. Informed Mr. Lockwood that he would attempt to get him information on the budget ahead of time.

D. Lockwood expressed his concern with the new staff and offered his assistance with the budget process.

Connie Mahon commented that John Clifford has had multiple conversations with the State in advance regarding the increase of construction fees. She indicated that he is making sure that everything that the Township is doing that may "look different this year" is acceptable.

Mayor Clark commented that John Clifford is a "smart guy" and is doing a great job on the budget.

Ed Dillio announced that the Middle Township Veterans Advisory Board and the American Legion are holding an open house Saturday from 9-11am. All are invited.

Ed Betto asked questions regarding the New Jersey Transit bus stop out front of Garden Lake MHP. Indicated that the bus no longer stops there and was told that the Township would need to request it through NJ Transit. He indicated that he was informed the bus will no longer stop on the "bend."

Connie will discuss the concern with NJ Transit.

D. Lockwood asked the status of the proposed amendment to recreation fees.

Kim Krauss indicated that the fees will be discussed at the 03/21 work session.

Committeeman Donohue informed the public of the upcoming Disk Golf Opening Day, to be held at the Ockie Wisting Complex on Saturday at 8:45am. The group has raised money for its own baskets and supplies and has met with the NJ DEP to see where the event can take place. The group has cleaned up the site with the Middle Township Recreation staff and people from various different states will be in attendance. "This is a long time coming." The committeeman articulated that this is "what we are looking for, different events and different partnerships." Ribbon cutting with be at 8:45am.

- Committeeman Donohue also referenced the veterans appreciation breakfast at 9am.
- Regarding the shopping cart ordinance, Committeeman Donohue stated that Mike Elias from Code Enforcement is moving forward with enforcing the ordinance. Committee is working on a revision to the code.
- Committeeman Donohue continued by commenting on Carol Struetts nomination for the "Middle Matters Award" and her role on the Economic Development Council. Voiced that she has "done a ton of work timelessly" and Brian Murphy will be filling her spot as Chair.
- Recognized the retirements of both Madonna Sill and Bob Bongiovanni as well as Joe "G." from Clean Communities.
- Mentioned Sturdy Savings Bank and their awarded RFP. "Sturdy has always done a great job for the town."

Committeeman DeVico reiterated Committeeman Donohue's comments above and also added that he has "a lot of work to do with the Public Works issues that were addressed tonight, as well as budget preparation."

Mayor Clark acknowledged the employee retirements and spoke of the Middle Township girls' basketball team win against Ocean City. "Congratulations to Coach Feracco on his retirement."

Committeeman Donohue reminded everyone about the upcoming special school election.
