- *Senior Vice Commander of DAV Chapter #44.*
- *Was also a Marine.*
- *Served in Vietnam from 1967-68.*
- *In charge of transportation and the vans that transport veterans from Cape May County to Philadelphia's VA Hospital and Wilmington's VA medical centers.*
- *He also has a van that transports veterans to local medical appointments depending on the availability of private physicians.*
- *He also travels to Vineland, Northfield and the Clinics located in Cape May.*
- *Has a total of three vans, one is usually traveling to Philadelphia every day, one to Wilmington, and the third is basically on a "first come, first served" basis.*

Allyn Penkethman:

- *Knows Nicholas from High School, her place of work.*
- *Is familiar with his brothers and sisters.*
- *Was enrolled in the Airforce for about 22 years.*
- *Retired when she came home.*
- *Born and raised here.*

Maureen Harden-Lozier:

- *Event being held on Saturday, March 12th from 9am – 11pm.*
- *Happening at the Thurston Elmer Wood American Legion Post #198.*
- *Sponsored by Post #198 and the Veterans Advisory Board.*
- *Light breakfast – coffee, donuts, fruit, etc.*
- *Free of charge.*
- *Purpose of holding the event is for members to get to know one another and express their ideas as well as concerns.*

Terms of Members and New Member – Reappointments – Potential Alterations to Memberships

Maureen Harden-Lozier:

- *There were four members whose terms came to a completion December 31st, 2015.*
- *They were all reappointed by the Governing Body.*
- *The contribution of two of those members' reappointed was discussed at previous meetings due to their consecutive absence at every meeting held.*
- *There are other people interested in holding a position on the board we would like to give an opportunity to.*

Krystal Arana:

- *Terms of current members are renewed at the end of every term until that individual member writes a letter resigning from their position.*
- *Only after a member resigns from their position can a new member be appointed to the board.*

Maureen Harden-Lozier:

- *Was not aware of this information.*
- *Has sent the two board members with consecutive absences letters informing them of the board's decision on plan of action.*
- *Would like Howard to be appointed as a member instead of an alternate member due to his dependable attendance and willing participation.*

Fundraising – Update

Maureen Harden-Lozier:

- *Shared the information she currently has on fundraising in a hand-out.*
- *Believes we are permitted to hold Games of Chance such as raffles and bingos, for example.*
- *Doesn't understand why the Veterans Advisory Board's future ability to fundraise would differ from the Animal Advisory Board's current ability to fundraise.*
- *Still has to clarify some issues with John Clifford, the Chief Financial Officer.*
- *Was told that the board's funds would be held with the township.*

Fred Trasatti, Jr.:

- *Mentioned that it cost him and his post \$1,500.00 this year to apply for a raffle license.*
- *Finds it to be expensive.*
- *Feels as if he was given a hard time to obtain a raffle license.*

Ed Dillio:

- *Believes that there is a one-time exception to holding one raffle or bingo per year as long as they are not held on a regular basis.*

Allyn Penkethman:

- *Thinks applying will make a difference being a volunteer board compared to a 401c3 or a 501c3 as stated in the hand-out..*

Joe Griffies:

- *Spoke to a couple representatives of other boards located within different municipalities and stated that they are budgeted through their townships.*

- *Those municipalities receive about \$5,000 a year and most of the time they don't spend all of it.*
- *To his understanding from the ordinance generated creating our board, our duty is to advise the Committee, hence Veterans "Advisory" Board.*
- *States that if the board was created to advise the Governing Body on projects deemed necessary for the well-being of veterans that the municipality should fund it.*

Any other unfinished Old Business

Fred Trasatti, Jr.

- *Informed the board of the law Governor Christie recently passed regarding Veterans with Special tags being exempt from having to pay at parking meters.*
- *Middle Township does not have parking meters.*
- *They are extending the law to make it mandatory throughout the whole State of New Jersey including North Wildwood, the municipality we were experiencing problems with regarding this topic in the past.*
- *This new law does not pertain to handicapped parking spots.*
- *A person must have a placard permitting them to park in a handicapped parking spot.*
- *Our problem in Cape May County is that not all Veterans are registered and the number of Veterans that are registered is not enough to be considered as a priority.*
- *File the first claim with the VA medical system because if any service related health problems occur in the future, for example a illness produced from time served, there will be record of the first claim.*

- *Utilize Nicholas as an advocate to attract younger veterans.*
