ORDINANCE NO. 1608-20 – AN ORDINANCE TO REPEAL ORDINANCE NO. 1237-06, WHICH ENACTED CHAPTER 116 (“DEVELOPMENT FEES”), AND TO REPLACE THE SAME WITH A COMPLIANT DEVELOPMENT FEE ORDINANCE AND ENACT CHAPTER 116 (“DEVELOPMENT FEES”) IN THE CODE OF THE TOWNSHIP OF MIDDLE - Following second reading, hearing, and consideration for adoption, Ordinance 1608-20 was adopted on motion by \_\_\_\_\_ seconded by \_\_\_\_\_ and passed on roll call. Complete Ordinance is on file in the Clerk’s Office.  
*WHEREAS, the Township of Middle, in September of 2006, adopted Ordinance No.: 1237-06, which enacted Chapter 116 of the Code of the Township of Middle regarding Development Fees; and  
WHEREAS, the Township Committee, having considered the enactment of N.J.S.A. 52:27D-329.1 as well as changes in the regulations and policies of the New Jersey Council on Affordable Housing regarding Residential and Non-Residential Development and the need for the Township to address the same.  
NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Middle, County of Cape May and the State of New Jersey as follows:*
  - Section 1.  
Ordinance No.: 1237-06, which enacted Chapter 116 of the Code of the Township of Middle, is hereby repealed and replaced by Chapter 116 entitled “Development Fees”, the provisions of which are fully incorporated herein as if set forth at length.*
  - Section 2.  
The various parts, sections and clauses of this Ordinance are hereby declared to be severable. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.*
  - Section 3.  
Any Ordinance(s) or parts thereof in conflict with the provisions of this Ordinance are hereby repealed. This Ordinance shall supersede, in its entirety, any previously enacted and/or inconsistent Ordinance(s) regarding the same.*
  - Section 4.  
This Ordinance shall take effect upon final adoption and publication in accordance with the law.*
  - Section 5.  
A copy of this Ordinance shall be placed on file with the Township Clerk.*
  - Section 6.  
Notice of the adoption of this Ordinance shall be published in a newspaper of general circulation in the Township of Middle and a newspaper of general circulation in Cape May County.*
  - Section 7.  
This Ordinance shall become effective twenty (20) days after final passage and publication, according*

9. RESOLUTION – SELF-EXAMINATION OF BUDGET – On motion by                      seconded by                      and passed on roll call, the following resolution was adopted.  
*WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and*  
*WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and*  
*WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of Middle has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2018 budget year.*  
*NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Middle that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:*
- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:*
    - a. Payment of interest and debt redemption charges*
    - b. Deferred charges and statutory expenditures*
    - c. Cash deficit of preceding year*
    - d. Reserve for uncollected taxes*
    - e. Other reserves and non-disbursement items*
    - f. Any inclusions of amounts required for school purposes*
  - 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).*
  - 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.*
  - 4. That pursuant to the Local Budget Law:*
    - a. All estimates of revenue are reasonable, accurate and correctly stated*
    - b. Items of appropriation are properly set forth*
    - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality*
  - 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.*
  - 6. That all other applicable statutory requirements have been fulfilled.*
- BE IT FURTHER RESOLVED, that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.*

11. RESOLUTION – AMEND 2020 BUDGET – On motion by                      seconded by                      and passed on roll call, the following resolution was adopted.  
*WHEREAS, the local municipal budget for the year 2020 was approved on the 2<sup>nd</sup> day of March, 2020, and*  
*WHEREAS, the public hearing on said budget has been held as advertised, and*  
*WHEREAS, it is desired to amend said approved budget,*  
*NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Middle, County of Cape May, that the following amendments to the approved budget of 2020 be made:*

12. RESOLUTION – ADOPT 2020 MUNICIPAL BUDGET – On motion by \_\_\_\_\_ seconded by \_\_\_\_\_ and passed on roll call, the following resolution was adopted.

*BE IT RESOLVED, by the Township Committee, the Governing Body of the Township of Middle, County of Cape May and State of New Jersey that it is hereby declared that the Local Budget of the Township of Middle for the year 2020 was introduced and approved at a regular meeting of the Township Committee held on March 2, 2020 and was thereafter advertised in the Herald-Times in its issue on March 11, 2020, which advertisement contained a notice of the date, time and place of the public hearing, and that at least one week prior to public hearing a complete copy of the approved budget as advertised was posted in the Middle Township Hall and made available to each person requesting the same during said week, and that sufficient copies of same are available for each person requesting the same at the scheduled public hearing; and*

*BE IT FURTHER RESOLVED, that the Local Budget of the Township for the year 2020 was hereby read by title only, and also had public hearing on April 20, 2020; and*

*FURTHER RESOLVED, that the Summary of Appropriations be made part of this resolution for the adoption of the budget for the year 2020; and*

*FURTHER RESOLVED, that the Local Budget of the Township of Middle for the year 2020 is hereby adopted.*

13. RESOLUTION - ESTABLISHING THE RATE OF INTEREST FOR DELINQUENT TAXES – On motion by \_\_\_\_\_ seconded by \_\_\_\_\_ and passed on roll call, the following resolution was adopted.

*WHEREAS, N.J.S.A. 54:4-67a permits the governing body by resolution to fix the rate of interest to be charged for the nonpayment of taxes, assessments, or other municipal liens or charges, on or before the date when they would become delinquent; and*

*WHEREAS, the statute fixes the rate of interest cannot exceed 8% per annum on the first \$1,500.00 of the delinquency and 18% per annum on any amount in excess of \$1,500.00, to be calculated from the date the tax was payable until the date that actual payment to the tax collector is made; and*

*WHEREAS, the Township of Middle adopted Resolution No. 27-20 setting the Rate of Interest for Delinquent Taxes rate of 8% per annum on the first \$1,500.00 of such delinquency and at the rate of 18% per annum on any amount in excess of the said first \$1,500.00; and*

*WHEREAS, due to the COVID-19 pandemic and the State and Federal declarations of a major disaster throughout New Jersey, the governing body of the Township of Middle wishes to change the rate of interest for future delinquent tax payments for the 2<sup>nd</sup> quarter tax, which is due May 1<sup>st</sup>;*

*NOW THEREFORE, BE IT RESOLVED, by the governing body of the Township of Middle in the County of Cape May that the rate of interest for taxes unpaid after May 10, 2020 is fixed at 0% for an additional 30 days; and*

*BE IT FURTHER RESOLVED, that the rate of interest for taxes unpaid shall be calculated from date of the quarterly payment until the date of actual payment; and*

*BE IT FURTHER RESOLVED, this Resolution shall be published in its entirety once in the official newspaper of the Township of Middle and a copy of this adopted Resolution forwarded to the Division of Local Government Services in the Department of Community Affairs*

*BE IT FURTHER RESOLVED, effective June 10, 2020 the rate of interest for taxes unpaid after May 1, 2020 is fixed at 8% on the first \$1,500.00 of delinquency and 18% per annum on any amount of taxes in excess of \$1,500.00 effective June 10, 2020*

14. RESOLUTION - AUTHORIZING THE MUNICIPAL TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED PROPERTY TAX BILLS - On motion by \_\_\_\_\_ seconded by \_\_\_\_\_ and passed on roll call, the following resolution was adopted.

*WHEREAS, due to the Covid-19 health crisis facing the State of New Jersey, Governor Murphy issued a State of Emergency in Executive Order 103. As a result, the State's fiscal year will be extended to September 30, 2020; and*

*WHEREAS, due to the State of Emergency, the Cape May County Board of Taxation will be unable to certify the tax rate and therefore, the Municipal Tax Collector will also be unable to mail tax bills on a timely basis; and*

*WHEREAS, the Municipal Tax Collector in consultation with the Municipal Chief Financial Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted tax levies.*

*NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middle as follows:*

1. *The Municipal Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the municipality for the third installment of 2020 taxes. The Tax collector shall proceed and take such actions as permitted by N.J.S.A. 54:4-66.2 and 54:4-66.3.*
2. *The estimated tax levy for 2020 is hereby set at \$52,759,093.15, this results in an estimated tax rate of \$1.28.*

3. *The Municipal Tax Collector must mail the estimated tax bills to property owners no later than June 30, 2020.*
4. *In accordance with N.J.S.A. 54:4-66.3, the third installment of 2020 taxes shall not be subject to interest until the later of; the grace period or the 25th, (twenty fifth) calendar day after the estimated tax bills are mailed. The estimated tax bills shall contain a notice specifying the date which interest may begin to accrue.*
