This is hereby created the "Middle Township Law Enforcement Community Engagement Committee." The committee would give a voice to a diverse group with a shared mission - to foster trust and mutual respect between the police and the community.

### SECTION 2: MEMBERSHIP

This Committee shall consist of nine (9) members appointed by the Governing Body, whereas the Chair Person shall be appointed by the Mayor, and said board shall be made up of a balanced mix of local clergy, educators, a representative from the Concerned Citizens of Whitesboro, a member of the local chapter of the NAACP, a representative from the township's social service partners, and three appointed members that reside in Middle Township.

The panel would include a liaison for the MTPD, who would furnish the committee with quarterly data on police interaction in the community, updates on new and existing programs, and partner with the committee to enhance communication and understanding of available resources.

The initial appointees to the Board shall serve terms as follows:

Member Term

4 Regular Members three-year term
3 Regular Members two-year term
2 Regular Members one-year term

Thereafter, all subsequent or reappointed members shall serve a term of three years commencing January 1. The members of the Law Enforcement Community Engagement Committee shall serve without compensation.

The Committee will meet on a quarterly basis and hold biannual public meetings with township residents to hear their concerns and ideas.

The Law Enforcement Community Engagement Committee shall have no policy-making powers, nor shall it have the power to hire employees or otherwise expend moneys.

<u>SECTION 3</u>: Any other Ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

20. RESOLUTION 298-20 – REQUESTING THE NEW JERSEY DEPARTMENT OF TRANSPORTATION TO CONDUCT A SPEED SURVEY ON ROUTE 9 – On motion By Committeeman Gandy seconded by Committeeman Norris and passed on roll call, the following resolution was adopted.

WHEREAS, the Township of Middle has received several complaints and requests for a speed limit survey on Route 9 between the Cape May County Zoo and Avalon Boulevard; and

WHEREAS, the Middle Township Committee believes it to be in the best interest of Middle Township that the New Jersey Department of Transportation conduct such a speed limit survey,

NOW, THEREFORE, BE IT RESOLVED, that the New Jersey Department of Transportation is requested to conduct a speed survey within the above limits to determine if a reduction in any of the posted speed limits is warranted.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be sent to the County Engineer, the Chief of Police of the Township of Middle and the Clerk of the Board of Freeholders.

21. RESOLUTION 299-20 – REQUEST COUNTY OF CAPE MAY TO CONDUCT TRAFFIC STUDY TO EVALUATE A 4-WAY STOP AT THE INTERSECTION OF BOYD STREET AND HAND AVENUE – On motion by Committeeman Gandy seconded by Committeeman Norris and passed on roll call, the following resolution was adopted.

WHEREAS, the Township of Middle is requesting that the County of Cape May explore the option of a 4-way stop sign at the intersection of Boyd Street and Hand Avenue; and

WHEREAS, the County of Cape May requires a resolution from the municipality in order to promulgate a traffic study.

NOW, THEREFORE BE IT RESOLVED, that the Township Committee of the Township of Middle, the governing body thereof, does hereby request a traffic study at the intersection of Boyd Street and Hand Avenue with regards to a 4-way stop sign.

22. RESOLUTION 300-20 – APPOINTING CONDITIONAL REDEVELOPER AND AUTHORIZING EXECUTION OF A MEMORANDUM OF UNDERSTANDING – On motion by Committeeman Gandy seconded by Committeeman Norris and passed on roll call, the following resolution was adopted. WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of rehabilitation or redevelopment; and WHEREAS, by way of Resolution 149-18 adopted on March 19, 2018, the Mayor and Committee of the Township of Middle (the "Township Committee") designated certain properties located with the Township of Middle, Cape May County, State of New Jersey as an "Area in Need of Rehabilitation" (the "Rehabilitation Area") pursuant to the Redevelopment Law; and

WHEREAS, pursuant to its plans for the revitalization of the Township of Middle, the Township Committee adopted a redevelopment plan for the Rehabilitation Area entitled "Redevelopment Plan for the Township of Middle, Cape May County, NJ 2018" dated April 16, 2018 (the "Redevelopment Plan") setting forth plans for the development, redevelopment, and rehabilitation of the Rehabilitation Area; and

WHEREAS, the property identified on the Township's Official Tax Map as Block 1450, Lots 5 and 10 (the "Property") are located within the Rehabilitation Area; and

WHEREAS, the Township has been in discussion with Cape May County (the "Conditional Redeveloper") regarding the rehabilitation and redevelopment of the Property; and

WHEREAS, Conditional Redeveloper has presented its rehabilitation and redevelopment concepts to the Township, and the Township and Conditional Redeveloper desire that the Property be rehabilitated and redeveloped in accordance with a Redevelopment Plan and any amendments thereto; and

WHEREAS, <u>N.J.S.A.</u> 40A:12A-1, <u>et seq.</u>, as amended and supplemented, provides for a process for redevelopment entities to enter into agreements with redevelopers to carry out and effectuate the terms of a redevelopment plan; and

WHEREAS, the Township and Conditional Redeveloper intend to commence exclusive negotiations toward the formulation of various agreements to develop the Property in accordance with the requirements of a Redevelopment Plan and any amendments thereto; and

WHEREAS, in such event, the Township desires to designate Cape May County as Conditional Redeveloper in order to negotiate with Conditional Redeveloper for a period of one hundred and eighty (180) days in an effort to agree upon such agreements for the rehabilitation of the Property; and

WHEREAS, the Township and Conditional Redeveloper desire to memorialize, in writing, their agreement under a non-binding Memorandum of Understanding that evidences the Parties' statement of intent.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Middle, County of Cape May, State of New Jersey as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. That Cape May County is hereby designated as "Conditional Redeveloper" for the Property and the Mayor and Township Clerk are hereby authorized to execute a Memorandum of Understanding between the Township and Conditional Redeveloper evidencing the Parties' agreement to conduct exclusive negotiations toward the formulation of various agreements for the rehabilitation of the Property.
- 3. This Resolution shall take effect immediately.

#### 23. PUBLIC COMMENT:

Stan Doniger, Rio Grande:

Asked what is the current total is in regards to police officers with relation to the budget

### Mayor Donohue:

- Gave reason behind the timing of hiring new officers
- Explained the department tries to employ between 52-54 officers at a time

# Rita K, 12 Maddison Avenue:

Asked if the Township is aware of any Air BnB's in the area; referenced various rental properties; spoke of concern about large amount of people renting properties

## Mayor Donohue:

- Stated the Township knows people are renting homes and apartments through Air BnB
- Explained residents are permitted to rent their home through that program
- Confirmed Rita's concern was in regards to large numbers of people renting a property

## Rita K, 12 Maddison Avenue:

 Reiterated concern is about large groups of people renting a property especially due to Covid-19

# Mayor Donohue:

- Stated the Township is aware of issues of large groups of renters in other towns
- Explained the Township can not screen every Air BnB renter group
- Further explained that if they receive a complaint and are notified of large groups and partying at a rental property than the police will handle the situation

## Rita K, 12 Maddison Avenue:

- Discussed recent party
- Asked about agenda item 19 in regards to leaf collection

### Mayor Donohue:

- Responded that item 19 on the agenda is for the free yard sale
- Explained that she was looking at the agenda for a different town and was in the wrong meeting

### COMMITTEE COMMENTS:

#### Committeeman Norris:

- Stated Spring Green is doing another phase at the Goshen Complex for grass
- Discussed soccer signups that are coming up; stated at the current time there would be no fees; added that if anyone has questions about the signups to reach out to the Recreation Department
- Spoke of the next summer concert at Ockie Wisting with Animal House; Stated the previous concert was the biggest yet with about 250 people safely socially distanced
- Discussed visits he made to various businesses within the Township; Spoke of trips to 609 Nutrition in Rio Grande and the new Bagel Bazaar in Cape May Court House; Urged residents to go and check out the local businesses in the area
- Stated football and cheerleading signups are still ongoing; commended the volunteers of these programs for all their hard work during these crazy times to keep types of programs going

#### Committeeman Gandy:

- Discussed public works efforts in trying to get clean ups done quickly and effectively following the previous weeks tropical storm
