### SPECIAL PRESENTATIONS OR DISCUSSIONS:

Proposed Ordinance Amendment RE: Stormwater Management Control

Vince Orlando, Engineer:

Gave background on the new regulations for stormwater management, put in place last; stated new regulation must be adopted

Rob Flynn, Superintendent of Public Works:

Explained the regulations are a complete change from the previous management of stormwater; discussed the new regulations and implementation of the same; reiterated that the Township must comply with the new regulations Vince Orlando, Engineer:

Discussed impact the new regulations will have on the Township; continued to discussed challenges of the new regulations

Mayor Donohue:

Asked if these regulations apply to projects already approved but not yet built out

Vince Orlando, Engineer:

Clarified the regulations apply to all new construction

Mayor Donohue:

Asked when this takes effect

Vince Orlando, Engineer:

Stated March 2, 2021

Mayor Donohue:

Asked what cost the new regulations would implement

Vince Orlando, Engineer:

Explained the regulations will not affect costs but just change the way business is currently done Mayor Donohue:

Asked about the difference will be with the new regulations for the space that used to be set aside for retention

Vince Orlando, Engineer: explained approvement process in relation to stormwater basins; explained state wants the Township to manage the maintenance characteristics of stormwater basins as a high level than already done Committeeman Gandy:

Asked how the new regulations will be implemented further ask if the Township will have to outsource these inspection jobs

Vince Orlando, Engineer:

Explained the inspections will have to be done in house; stated the new regulations and process will require them to increase staffing within the public works department; anticipates this being a full time or 20 hour a week job for someone in the future

Mayor Donohue:

Asked for clarification on what the job would entail

Vince Orlando, Engineer:

Explained what the position would entail

Rob Flynn, Superintendent of Public Works:

Further discussed the work that must be done to maintain these regulations

Mayor Donohue:

Asked if engineer should be aware of these new regulations

Vince Orlando, Engineer:

Stated most engineer will be aware of these changes when coming before the Planning Board

Mayor Donohue:

Asked if there would be additional permitting at a State level

Vince Orlando, Engineer:

Stated no, the State has put all the regulations back onto the Municipalities; explained the state no longer will have any involvement

### Mayor Donohue:

- Asked how the state will enforce the new regulations

Vince Orlando, Engineer:

- Explained the State comes down once a year to preform a review of the Township operations

### Mayor Donohue:

- Asked if there was a timeline for when changes must be met or if the new regulations overall just start in March Vince Orlando, Engineer:
  - Stated in March the new rules and regulations will be in place

# Kimberly Krauss:

- Clarified the new ordinance is in review by the County

# Vince Orlando, Engineer:

- Stated yes; explained they were required to forward the ordinance over to the County for review; further explained that all the municipalities are adopting the standards as the state has implemented them and are incorporating them into their separate ordinances

### Committeeman Gandy:

- Asked what must be done right away

### Vince Orlando, Engineer:

- Stated nothing must be done other than implementing the new rules and regulations

### Rob Flynn, Superintendent of Public Works:

- Explained as for the review of zoning at the planning board level it will change the reviews

# Vince Orlando, Engineer:

- The planning board will have to have engineers comply with the new rules and regulations

### Mayor Donohue:

- Asked how the new regulations affect single family homes

# Vince Orlando, Engineer:

- Stated the regulations would be affect single family homes but would affect larger developments

# Kimberly Krauss:

- Explained once the Township gets response back from the County regarding the ordinance, it can be placed on for adoption by the Township at a meeting in March

# Stan Doniger, Rio Grande:

- Asked how the new regulations will affect older basins

### Vince Orlando, Engineer:

- Stated old basins not have to be refitted to meet new standards; explained that there may be an increase ein reporting back to the town of what maintenance has been done and the Township will have to keep a record of it Stan Doniger, Rio Grande:

- Asked how non-compliance with existing basin will be handled

## Kimberly Krauss:

- Explained that does not relate to this ordinance

# Stan Doniger, Rio Grande:

- Asked if there is a penalty for non-compliance

# Vince Orlando, Engineer:

- Stated there would be no penalty for non-compliance

Proposed Ordinance Amendment

RE: Bulkheads

## Kimberly Krauss:

- Gave background on current bulkhead ordinance; discussed changes to fees in the current ordinance to meet the fees within other Township's bulkhead ordinances; explained change in escrow fee will assist in the back and forth between the applicants and Township; continued to discuss various changes to the ordinance

# Vince Orlando, Engineer:

- Explained responsibility for accepting applications will be shifted to the Zoning Office' explained benefits to shifting the applications from the Clerk's Office to Zoning Office

# Mayor Donohue:

- Explained when ordinance was originally put in place it was right after Hurricane Sandy with various bulkhead issues

# Kimberly Krauss:

- Explained at the time the original ordinance was put in place there was no standard for bulkheads in the Township

Pump Station Improvements Phase 1

## Angelo Bufaino, Mott MacDonald:

- Discussed receipt of bids for Phase 1 of the Pump Station Improvement Project; explained items on the bid specifications; stated bids came in higher than anticipated

## Committeeman Gandy:

- Asked how the bids could come in over a million and a half dollars over the estimated cost
- Asked if the pump stations are being rebuilt completely

# Angelo Bufaino, Mott MacDonald:

- Explained the pump stations are being retrofitted
- Further explained process of establishing what upgrades each pump station needs; stated there were quite a few items added for each pump station to keep them running for the long term
- Stated he has hoped for more favorable costs
- Explained the \$100,000 allowance

## Committeeman Gandy:

- Again, asked why the low bid came in over double what the estimated cost was

### Angelo Bufaino, Mott MacDonald:

Explained the difference in cost was not what was missed but due to various items added to improve the pump stations the best for long term usage

### Kimberly Krauss:

- Asked that Committee keep in mind that the four pump stations in Phase 1 are the worst pump stations within the 21 pump stations in the Township
- Explained that the upgrades must make it so the Township staff are able to work with these pump stations to the best of their ability; further explained that the state these four pump stations are in that the added items would help the staff maintain these stations better
- Stated the oldest pump station was built in the early 1980s
- Continued to discussed factors that could add to the increase in the project cost
- Stated the Committee must make a decision as to whether to scale back on some items in the pump stations or to continue with what was bid out; stated to keep in mind these pump station will not be upgraded for a while
- Explained three lowest bidders were asked for extensions to award contract
- Ask Susan Quinones to talk about the financing in place currently for the project and the next steps for the project Susan Quinones, Chief Financial Officer:
  - Explained original resolution was passed for 2.5 million dollars to upgrades the pump stations
  - Discussed various aspects looked at causing more costs with the MUA before establishing what was needed for improving the pumpstations
  - Further discussed aspects taken into consideration for the sewer funding to help with the improvements
  - Explained the Township funds have been able to cover unexpected costs related to the project
  - Stated currently the remaining funds are short to award any of the bids received
  - Stated the funds paid to the MUA have decreased the last two years; explained effect this trend has had on the sewer budget
  - Continued to discuss benefits of phasing the improvements
  - Discuss various options for obtaining funds

### Mayor Donohue:

- Asked Steve Mills for his thoughts on the proposed upgrades for the pump stations

#### Kimberly Krauss:

- Stated Steve was no longer in the meeting; Asked Rob Flynn for his input

# Rob Flynn, Superintendent of Public Works:

- Explained benefits of the added upgrades o the pump stations
- Spoke of the current conditions of the pump stations

### Mayor Donohue:

- Confirmed the 4 pump stations in this phase are the ones in the worst condition
- Discussed the funding for the improvements
- States he understand the need to upgrades these pump stations; discussed need for the upgrades but insufficient funds
- Discussed benefits of upgrading the pump stations

# Angelo Bufaino, Mott MacDonald:

- Explained the cost for the other pump stations will come closer to the estimated cost as they are newer and don't need as much work
- Reiterated that the pump stations in Phase 1 are in the worst shape and will require the most upgrades; explained due to this reason the costs are elevated

## Mayor Donohue.

- Asked that if the Township decides to move forward with the bid submitted where do they go from there Kimberly Krauss:
  - Stated that an extension was asked until April
  - Asked Susan Quinones what timeline she would need to obtain funds

## Susan Quinones, Chief Financial Officer:

- Explained process for obtaining more funds to continue with the project
- Discussed previously established funds for the project

# Mayor Donohue:

- Explained efforts were made to not have too much lag time between phases and have funds in place
- Recommended moving forward with Susan Quinones' proposal
- Asked Susan Quinones how the timeline to obtained the funds could affect the timeline of the project Susan Quinones, Chief Financial Officer:
  - Stated once the capital ordinance is put together the time frame may stay the same
  - Explained benefits of using a capital budget ordinance to establish funds

# Kimberly Krauss:

- Asked Angelo if, the way the bid specifications reads, do they have to award all or nothing Angelo Bufaino, Mott MacDonald:
  - Stated yes, it is an award all or nothing bid

## Mayor Donohue:

- Explained that in order to award that funds must be in place

## Committeeman Gandy:

- Stated he understands this is needed but he was surprised by the elevated cost

# Mayor Donohue:

- Explained there is time to review the submitted bids and see what caused the cost to elevate

# Steve Mills, Sewer Administrator:

- Explained that the stations are failing and that they have done everything they can to keep them running for as long as they have; further explained that they are to the point where they have to be updated
- Stated some of the electronic added to the upgrade project could be removed but does not believe those are what are driving up the cost
- Stated that long term the upgrades are needed and will help keep the pump stations running for longer

### Mayor Donohue:

- Stated goal is to get the stations upgraded and keep running for a long time
- Expressed appreciation for Steve Mill's knowledge of what is needed to upgrade the stations

### Kimberly Krauss:

- Explained these system upgrades will allow the Township to monitor our own systems without having to ask the County; further explained additional benefit will be able to tell if the numbers are rising there could be problem with the pump station

# Committeeman Gandy:

- Discussed shock in cost difference between estimated cost and bid received

# ${\it Steve \ Mills, \ Sewer \ Administrator:}$

- Explained if cost had been estimated higher than they could have adjusted in number of stations upgraded at a time Mayor Donohue:
  - Stated the four pump stations in this phase can not wait

### Kimberly Krauss:

- Explained size of the pump stations can affect the costs as well
- Stated some pump stations being repaired later on will be smaller and have some cost deviation in them as well Committeeman Gandy:
- Stated he understands reason for costs just unsure why anticipated cost was not presented higher Kimberly Krauss:
  - Stated Susan Quinones will begin to prepare establishing funds
  - Explained they have until the end of April to award a contract

- Stated they can dive into the costs before award so they are more prepared for the next phase
