* Spoke of trying for Grant again to do flower boxes at end of driveway at Goshen Complex with solar lights to mark entrance off of Goshen Rd.

Comments:

Josh spoke about his work on the Tree Ordinance that he is working on. Has looked at other ordinances, but not sure how to work them into his. He does not want to do one that is just going to get buried.

Vilma said she and John Ludlam wrote a tree ordinance years ago, but does not think anyone ever looked at it. She handed out information on trees and CAFRA regulations, although some have been changed.

Spoke about Department of Agriculture wanting to heavily regulate native plants. Basically, if a plant is considered rare or threatened in the state, you are not allowed to plant it, replant it, grow it or give it away. That includes a lot of plants that are common in native gardening. The way they are going about it is incorrect. They are concerned about contamination of native plants from outside sources, although cross contamination can still be done by birds flying and dropping seeds from different states.

We can send an email stating our stance on this. Fourth time this bill has come up, the copy he has is from 2013. This could affect a lot of gardening businesses in NJ that sell native plants, which includes a huge percentage of nurseries. Something like this law would be very hard to enforce. It is pretty much left open to whomever is enforcing this law, which that in itself is dangerous. They are not doing anything about the stuff that is a major problem.

Tarin has been trying to work with the schools on recycling, but has been getting nowhere. Main problem is the schools are not recycling. The problem is the janitors need a triple sided bin so they can recycle. She spoke with Judy Fala and is trying to get something set up regarding the schools. She has been reading all of the articles that there is no longer a market for recyclables and a lot of cities that are no longer recycling. In speaking with Lynn, she wants to continue with the recycling program, but her main concern is if we finally get the schools to recycle and then the program is stopped. Going to keep trying to get something started with the schools.
