### SPECIAL PRESENTATIONS OR DISCUSSIONS:

2021 Budget Presentation – Leon Costello, Ford-Scott & Assoc. & Susan Quinones, CFO

#### Mayor Donohue:

- Explained delay in budget introduction due to unforeseen circumstances related to COVID.
- Discussed lack of information from the State.
- Also spoke of new legislation requiring hospitals to pay a host-community benefit; Thanked Cape Regional for their efforts.
- Explained federal stimulus of \$1.9 million will be coming in two payments, however, still awaiting word on what funds can be used towards.
- Thanked everyone involved in budget preparation during unprecedented times.

## Leon Costello, Ford Scott & Assoc:

- Reiterated Mayor Donohue's comments with regard to waiting for guidance on stimulus funds.
- Discussed processing a budget amendment once guidance is received.
- Provided budget overview; two-cent tax increase proposed.
- Spoke of decline in surplus due to COVID, but stimulus money could replace the same.
- $\quad Explained \ how \ funds \ from \ the \ hospital \ are \ incorporated \ into \ the \ budget.$
- Spoke of anticipation of stimulus rules to come out within the week.

## Susan Quinones, CFO:

- Described 5 revenues most impacted by COVID-19.
- Reviewed a few small increases in revenue.

## Leon Costello, Ford Scott & Assoc:

- Explained that \$278,000 equals one penny.
- Discussed that the figures provided by Susan equate to just about two cents.
- Spoke of ultimate goal to use stimulus funds to bring down the proposed increase.

# Susan Quinones, CFO:

- Again, listed revenues with the most significant impact on the budget: hotel/motel tax, municipal court, construction, ambulance fees and interest on investments.

## Mayor Donohue:

- Continued to discuss budget impacts caused by pandemic.
- Spoke of some areas where costs were down such as gas and education and training.
- Discussed hiring freeze in an attempt to control costs.
- Recognized effects felt by business owners and residents; will work hard to keep tax increase to a minimum without long-term effects.

## Committeeman Gandy:

- Reiterated that the Township will do everything possible to reduce the rate; will see how it plays out from the State.

## Committeeman Norris:

- Echoed Committeeman Gandy's comments.
- Commented on tough year and money lost.
- Thanked all involved in budget preparation.

Leon Costello, Ford Scott & Assoc.:

- Reviewed past CAP bank balances; have never gone to the maximum amount which can be used for the time being this year; still have \$972,520 leftover.

### Mayor Donohue:

- Explained the intent is never to use the CAP Bank unless necessary.

Quanette Vasser-McNeal:

- Spoke of properties sold in Whitesboro through public land sales.

Mayor Donohue:

- Explained purpose of public land sales; feels new land sale list is diverse.
- Further explained that once sold, the properties go back on the tax rolls.
- Discussed process of how lots are selected for public sale.

Quanette Vasser-McNeal:

- Described rich history in Whitesboro.
- Spoke of last land sale and being unable to compete with other bidders.

Kimberly Krauss:

- Explained that properties sold at last sale sold to Middle Township residents.
- Further discussed how land sales benefit the Township tax rolls.

- Further explained her position on public land sales and history of Whitesboro.
- Asked if he land sale process can be changed to accommodate residents of a particular community.

Mayor Donohue:

- Spoke of statutes that govern the process of land sales.
