RESOLUTION 270-21 – OF THE TOWNSHIP OF MIDDLE, COUNTY OF CAPE MAY, DECLARING ITS CONTINUED INTENT TO COMPLY WITH ITS CURRENT AND FUTURE MOUNT LAUREL OBLIGATIONS VOLUNTARILY AND TO RENDER ANY MOUNT LAUREL LAWSUITS AS UNNECESSARY LITIGATION – On motion by Committeeman Gandy seconded by Committeeman Norris and passed on roll call, the following resolution was adopted.

WHEREAS, through the <u>Mount Laurel</u> line of cases, our courts declared that the New Jersey Constitution requires every municipality to use its zoning power in a manner that creates a "realistic opportunity for the construction of its fair share" of the region's low- and moderate-income housing; and

WHEREAS, over the years, municipalities have been strongly encouraged to achieve compliance voluntarily either (1) through the substantive certification process formerly utilized by the now-defunct New Jersey Council on Affordable Housing or (2) the Declaratory Judgment Action ("DJ Action") process in the Courts; and

WHEREAS, municipalities that took good faith actions to achieve compliance voluntarily were granted "temporary immunity" which barred all exclusionary zoning lawsuits during the compliance process; and WHEREAS, on March 8, 2015, the New Jersey Supreme Court issued <u>In re Adoption of N.J.A.C. 5:96 & 5:97 by N.J. Council on Affordable Housing</u>, 221 N.J. 1 (2015)("Mount Laurel IV") which, in relevant part, (1) declared COAH to be a defunct state agency; (2) provided a judicial replacement for COAH's administrative forum for municipalities to achieve compliance; and (3) created an avenue for municipalities to obtain immunity from challenges to their fair share plans.

WHEREAS, <u>Mount Laurel IV</u> also included guidance to the designated judges who would be evaluating municipal fair share plans; and

WHEREAS, with regard to temporary immunity, the Court in Mount Laurel IV directed trial judges to "endeavor to secure, whenever possible, prompt voluntary compliance from municipalities in view of the lengthy delay in achieving satisfaction of towns' Third Round obligations" (221 N.J. at 33)(emphasis added); and

WHEREAS, by stating "whenever possible," it is clear that the Court recognized that circumstances could arise that would hinder a municipality's ability to achieve "prompt voluntary compliance;" and

WHEREAS, the Court also created a legal standard to be applied by trial judges when revocation of immunity is at issue; and

WHEREAS, specifically, the trial judge must first make a finding that the goal of prompt voluntary compliance cannot be accomplished (<u>Ibid.</u>); and

WHEREAS, if the trial judge reaches that conclusion, it must also find that the municipality "is determined to be constitutionally noncompliant." (<u>Ibid.</u>)(emphasis added); and

WHEREAS, under those circumstances, the trial court may revoke immunity and "may authorize exclusionary zoning actions seeking a builder's remedy to proceed against the town...." <u>Ibid.</u> (emphasis added); and

WHEREAS, even in cases where a town is "determined to be constitutionally noncompliant," a trial judge has the power to adjudicate a <u>Mount Laurel</u> matter without involvement of a developer seeking a builder's remedy by invalidating the municipality's zoning ordinance and ordering it to rezone in a manner that achieves compliance; and

WHEREAS, this is especially so in cases where the interests of low- and moderate-income households are being protected by statewide affordable housing advocate Fair Share Housing Center ("FSHC"); and

WHEREAS, in 2019, the Township filed its DJ Action and secured temporary immunity thereby demonstrating its bona fide commitment to achieve compliance voluntarily and without the need to be forced into compliance via exclusionary zoning and builder's remedy lawsuits; and

WHEREAS, unlike many municipal DJ Actions, no builder, developer, or property owner in the Township sought to intervene or asked to have its property to be included in the Township's Fair Share Plan; and

WHEREAS, as is true with every <u>Mount Laurel</u> DJ Action, FSHC participated in the Township's DJ Action as an interested party, thereby protecting the interests of the region's low- and moderate income households without the need for exclusionary zoning and builder's remedy lawsuits; and

WHEREAS, the Township's legal and planning professionals engaged in negotiations with FSHC for purposes of establishing (1) Middle's "fair share" obligations; and (2) a detailed framework regarding the manner in which Middle would satisfy its fair share, i.e. its Fair Share Plan; and

WHEREAS, the negotiation process was hampered for a number of reasons, but significant delays occurred due to the worldwide Covid-19 pandemic; and

WHEREAS, indeed, the Township's Special <u>Mount Laurel</u> Counsel suffered from the Covid infection both in late 2020 and early 2021; and

WHEREAS, in addition, members of the Township's administrative staff also became infected, which forced the closing of Township Hall for a significant period in 2020; and

WHEREAS, under those clear extenuating circumstances, the Township's immunity remained in full force and effect; and

WHEREAS, in addition, FSHC never asked the trial judge to revoke immunity not only due to the extenuating circumstances, but because it was clear that the Township took no action or inaction demonstrating that it was "determined to be constitutionally noncompliant;" and

WHEREAS, in fact, in March of 2021, FSHC filed correspondence with the trial judge expressly consenting to an extension of the Township's immunity; and

WHEREAS, to date, the trial judge has not issued any order revoking the Township's immunity; and

WHEREAS, it is the Township's position, therefore, that its immunity from exclusionary zoning and builder's remedy lawsuits remains in full force and effect; and

WHEREAS, as proof of the Township's steadfast commitment to voluntary compliance, in April of 2021, the Township Committee appointed and retained professional planners from CME Associates with particularized expertise in assisting municipalities like Middle to achieve <u>Mount Laurel</u> compliance; and

WHEREAS, on May 3, 2021, the Township rezoned several parcels of property, which was the culmination of over a year of effort between the Township Committee, the Middle Township Planning Board, formal committees, and members of the public; and

WHEREAS, the zoning changes were consistent with the Township's Master Plan and Reexamination Report adopted by the Middle Planning Board November 2020; and

WHEREAS, an analysis conducted by the CME planners reveals that the recent zoning changes could increase the number of residential units in Middle by roughly 1,400; and

WHEREAS, the recent zoning changes did not include provisions mandating the construction of affordable housing; and

WHEREAS, however, that omission was clearly not based upon an intent to exclude low- and moderate-income households, nor did the Committee seek to demonstrate that it is "determined to be constitutionally noncompliant;" and

WHEREAS, rather, inasmuch as the Township and FSHC have yet to reach common ground on their negotiations, the Township Committee envisioned sequential actions, where the overarching Master Planbased zoning changes would be accomplished first, followed by targeted rezonings on parcels that will require affordable housing based upon the Settlement Agreement ultimately reached with FSHC; and

WHEREAS, those additional zoning amendments will be the key components to the Township's Fair Share Plan and will permit Middle to achieve compliance voluntarily, which has been its primary goal since the day it filed its DJ Action in 2019; and

WHEREAS, as an additional demonstration of its commitment to voluntary compliance, the Township is currently considering adopting zoning amendments that require affordable housing prior to the execution and court approval of a Settlement Agreement between Middle and FSHC; and

WHEREAS, to be clear, therefore, regardless of the terms ultimately agreed upon by FSHC and the court, the Township remains committed to comply voluntarily with its affordable housing obligations; and WHEREAS, this commitment to comply extinguishes any possible claim that Middle Township is "determined to be constitutionally noncompliant" and therefore must be forced to comply via exclusionary

WHEREAS, the Township Committee of the Township of Middle desires to obtain Plan Endorsement from the State Planning Commission; and

WHEREAS, Plan Endorsement is a voluntary review process developed by the State Planning Commission to provide the technical assistance and coordination of the State for municipalities, counties, and regional agencies to meet the goals of the State Planning Act and State Development and Redevelopment Plan; and WHEREAS, the State Planning Act recognizes that coordination of State action is necessary to help municipalities develop New Jersey's economy while protecting the natural, historic and recreational resources, providing adequate and diverse housing, and redeveloping our cities and older suburban areas; WHEREAS, the purpose of the Plan Endorsement process is to increase the degree of consistency among municipal, county, regional and state agency plans with each other and with the State Plan and to facilitate the implementation of these plans with the primary focus on where and how development and redevelopment can be accommodated in accordance with the State Plan; and

WHEREAS, the State Planning Rules and Plan Endorsement Guidelines establish a comprehensive and coordinated planning process in order for a municipality to consider, and update as necessary, master plans, functional plans, development regulations and capital plans to be consistent with the State Plan and achieve plan endorsement; and

WHEREAS, through plan endorsement, master plans, functional plans, development regulations and capital plans should be coordinated and supportive of each other; and

WHEREAS, the State Planning Rules and Plan Endorsement Guidelines incorporate, and expand upon, the principles of the Municipal Land Use Law in order to help towns plan for a sustainable future; and WHEREAS, pursuant to the Municipal Land Use Law, N.J.S.A. 40:55D-27, the Mayor may appoint one or more persons as a citizens' advisory committee to assist or collaborate with the planning board in its duties, including adoption of, and amendment to, the master plan to guide the use of lands within the municipality in a manner which protects the public health and safety and promotes the general welfare of the community; and

WHEREAS, the Plan Endorsement Guidelines and State Planning Rules require the appointment of a Plan Endorsement Advisory Committee to guide the municipality through the Plan Endorsement process; and WHEREAS, the Plan Endorsement Advisory Committee shall consist of between 5 and 10 members, including one representative of the governing body, a Class IV member of the planning board; one

representative of a local board, commission or committee who is not a member of the planning board; and two representatives of the public that do not hold a position, employment or office with the municipality. NOW THEREFORE BE IT RESOLVED that the Township Committee of the Township of Middle does hereby approve and adopts the following:

Middle Township establishes a Plan Endorsement Citizens' Advisory Committee consisting of between 5 and 10 members as follows:

- 6. Gary Farrow, Member of the Public
- 7. Tracey Cardwell, Member of the Public

The members of the Citizens' Advisory Committee shall serve at the pleasure of the Mayor; and The Citizens' Advisory Committee shall report findings and conclusions of its actions performed pursuant to the State Planning Rules and Plan Endorsement Guidelines, and make recommendations to the Planning Board on next steps, but shall have no power to vote or take other action required of the Planning Board; and

The Citizens' Advisory Committee shall also report to the Governing Body at least once on the status of plan endorsement; and

The Citizen Advisory Committee shall be entitled to call to its assistance any personnel of any municipal department or consultant thereto as it may require in order to perform its duties; and

The Citizens' Advisory Committee is established for the purpose of:

Guiding the plan endorsement process for the municipality;

Increasing public awareness of, and participation in, the plan endorsement process for the community; Serving as the liaison with the state, county, regional agencies and local officials throughout the plan endorsement process;

Assisting the municipality in meeting the deadlines of plan endorsement;

Take the lead on completing the municipal self-assessment and submitting the required planning documents to the Office of Smart Growth;

Helping to facilitate community visioning as described in the Plan Endorsement Guidelines and community visioning standards;

Reporting the findings and conclusions of the self-assessment and community visioning to the local planning board for its review; and

Negotiating a draft Action Plan with the Office of Smart Growth, in collaboration with the planning board and governing body, to consist of actions that should be taken to adopt and/or update plans, ordinances and regulations in order to meet the plan endorsement requirements;

Facilitating completion of the Action Plan items in order to achieve endorsement by the State Planning Commission and enjoy the benefits available to the municipality as a result of the endorsed plan. THEREFORE, BE IT FURTHER RESOLVED that the Clerk of the Township of Middle shall transmit a copy of this resolution and the notice as required in the State Planning Rules to the State Planning
