5. **TABLED** ORDINANCE NO. 1643-22 - AN ORDINANCE PROHIBITING THE USE AND OPERATION OF BOUNCE HOUSES AND/OR OTHER INFLATABLES ON TOWNSHIP PROPERTY

- Following second reading, hearing, and consideration for adoption, Ordinance 1643-22 was adopted on motion by seconded by and passed on roll call. Complete Ordinance is on file in the Clerk's Office.

WHEREAS, the Township of Middle is the owner of several properties that are the site of public parks, recreation fields, community centers, etc. that are utilized for Township-sponsored events and activities as well as events organized and coordinated by outside organizations and third parties not associated with the Township; and

WHEREAS, the Township has previously permitted outside organizations and/or third parties to utilize bounce house(s) or other similar inflatable recreation apparatus(es) during events on said Township-owned properties; and

WHEREAS, the Township has required those outside organizations and/or third parties utilizing bounce house(s) on Township-owned properties to obtain certificates of insurance indemnifying the Township from liability regarding the use of same; and

WHEREAS, the Township has observed the use of bounce house(s) by outside organizations and/or third parties that were not approved by the Township nor was insurance coverage provided; and

WHEREAS, the Township has investigated obtaining insurance coverage through the Township for the use of said bounce house(s) so as to avoid any lapses in coverage as a result of the aforesaid, and having determined that the Township's insurance carrier does not provide coverage for liability regarding the use of bounce house(s) on Township property; and

WHEREAS, as part of its continuing duty to protect the health, safety and welfare of its residents, the Township Committee has determined that the use of bounce house(s) and other inflatables, as defined hereinafter, creates certain inherent and undeterrable risks to the safety of participant(s), observer(s), passersby and/or any other individual on Township property and poses the risk of liability in the absence of coverage,

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Middle, County of Cape May and the State of New Jersey that the following new Chapter of the CODE OF THE TOWNSHIP OF MIDDLE, is hereby created as follows:

Section 1. Prohibition on the Use of Bounce Houses and Inflatables on Township-Owned Property. No person, organization, entity or otherwise shall be permitted to use, operate or otherwise utilize a bounce house or other inflatable on Township-owned property.

Section 2. Definitions

Bounce house(s) or inflatable, as used in this section, means an amusement device that incorporates a structural and mechanical system and employs a high strength fabric or film that achieves its strength, shape, and stability by tensioning from internal air pressure; a large plastic structure, usually in the shape of a building, that is filled with air and that children and/or adults jump up and down on.

Section 3. Penalties

Any individual, organization, or other such entity that shall be convicted of a violation of this chapter shall, upon conviction thereof by any court authorized by law to hear and determine the matter, be subject to a fine of up to \$500.00 for a first offense and a fine of up to \$1,000.00 for each subsequent violation(s).

Section 4

A copy of this Ordinance shall be placed on file with the Township Clerk.

Section 5.

Notice of the adoption of this Ordinance shall be published in a newspaper of general circulation in the Township of Middle and a newspaper of general circulation in Cape May County.

All other Ordinances in conflict or inconsistent with this Ordinance are hereby repealed to the extent of such conflict or inconsistency.

Section 7.

Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable. Section 8.

This Ordinance shall become effective twenty (20) days after final passage and publication, according to law.

ORDINANCE NO. 1645-22 AN ORDINANCE AMENDING CHAPTER 204, ENTITLED "SEWERS", OF THE CODE OF THE TOWNSHIP OF MIDDLE On motion by Committeeman Norris seconded by Mayor Donohue and passed on roll call, Ordinance No. 1645-22 passed first reading. Second reading, public hearing and consideration for adoption will be held on 05/16/2022 at 6:00 p.m.

WHEREAS, to protect the public health, safety and welfare of the citizens of the Township of Middle, there is a need to upgrade lateral service to commercial properties to incorporate a 6-inch lateral sewer line; and WHEREAS the Township Committee also deems it appropriate to enact a procedure to allow commercial properties which will have less sewer flow usage to appeal the requirement of the enhanced lateral size and to establish a procedure for the appeal.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS

SECTION 1: The Averments set forth above shall be incorporated herein as if set forth at length.

SECTION 2: The following section shall be added to Chapter 204 as an amendment and shall be inserted in Section 204-22C(1) of that Chapter as subsection "(c)":

204-22C(1)(c) LATERAL UPGRADES / FLOW METERS /APPEAL PROCEDURES

- (i) All new commercial construction shall be required to install a 6-inch diameter lateral. For commercial developments containing multiple, separate units, each individual unit must be provided with its own, independent lateral connection. Each commercial lateral connection must be provided with separate clean out located at the building property line, accessible to the Township.
- (ii) All new or existing commercial units shall be required to install an individual water flow meter if not serviced with Township water or the service recipient shall pay the default service rate set forth in the attached Schedule A-1, which is predicated upon DEP guidelines.
- (iii) In the event that a new commercial property is serviced by a preexisting 4-inch lateral and the service recipient can demonstrate that the flow warrants the installation of a 4-inch line, then said service recipient may appeal to the Township for relief permitting the 4-inch lateral to remain.
- (a) such appeal shall be initiated by providing the following:
- $(1)\ A\ detailed\ letter\ to\ the\ Administrator\ requesting\ the\ proposed\ relief;$
- (2) A written calculation by a licensed engineer or architect demonstrating the actual flow of the proposed commercial unit;
- (3) Internal inspection by CCTV of the existing lateral or other evidence satisfactory to the Township establishing the existing condition of the preexisting lateral and acceptability for continued use;
- (4) A detailed diagram of the building; and
- (5) a \$500 escrow fee to cover the cost of the appeal review
- (b) The appeal shall be decided by the Sewer Engineer, whose determination shall be binding.
- (c) Further, in the event that the use of such a commercial premises changes, then the new service recipient must demonstrate the level of flow usage to justify the continued use of a 4-inch lateral, or the service must be upgraded to a 6-inch lateral.

<u>SECTION 3</u>: Any other Ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

<u>SECTION 4</u>: Should any section, paragraph, sentence or clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect and to this end the provisions of this Ordinance are hereby declared to be severable.

<u>SECTION 5</u>: This Ordinance shall become effective immediately upon final passage and publication, according to law.


