NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Middle, in the County of Cape May, and State of New Jersey, that:

Chapter 250-411 TR Town Residential shall be amended to include a new permitted use under subsection A, and shall read as follows:

TR Town Residential.

A. Purpose: to recognize those areas where small-lot and multifamily residential development exists and where the presence of adequate infrastructure permits additional development compatible with existing development.

- B. Permitted uses:
- (1) Single-family.
- (2) Two-family residential dwellings, with sewer only.
- (3) Townhouse and multifamily dwelling units with sewer, except in the Cape May Court House Overlay Zone, in accordance with design standards.
- (4) Care facilities on a minimum of five acres.
- (5) Inclusionary housing development

a. Any development of five (5) or more housing units within the TR District shall include a mandatory set aside of at least twenty percent (20%) of units to be made affordable to low and moderate-income households in accordance with the Affordable Housing provisions of the Township Code found in Chapter 250-801 et seq.

b. Inclusionary development shall be permitted to occur in any combination of single-family dwellings, two-family dwellings, townhouse dwellings, or multi-family dwellings.

c. Any inclusionary development shall be permitted to have a maximum gross density of twelve (12) dwelling units per acre. This density shall be applied to the gross development tract acreage irrespective of any lands that are undevelopable due to wetlands, wetlands buffers, or other similar constraints.

d. The minimum lot area for any inclusionary development shall be as follows:

- (i) Single-Family Dwelling 5,000 square feet
- (ii) Two-Family Dwelling 3,000 square feet per dwelling (iii) Townhouse Dwelling 2,000 square feet per dwelling
- (iv) Multi-Family Dwelling 40,000 square feet
- e. The minimum required lot frontage for any inclusionary development shall be as follows:
- (i) Single-Family Dwelling 50 feet
- (ii) Two-Family Dwelling 30 feet per dwelling
- (iii) Townhouse Dwelling 20 feet per dwelling
- (iv) Multi-Family Dwelling 150 feet

f. multi-family buildings within an inclusionary development shall be permitted to have a maximum building height of three (3) stories and forty (40) feet.

g. The requirement for Non-Contiguous Parcel clustering as found in Section 250-625 of the Township Code shall not be required of any inclusionary development project.

Severability. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held by a court of competent jurisdiction to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect and shall be deemed valid and effective.

Inconsistencies. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the municipality, the provisions hereof shall be determined to govern and those inconsistent provisions shall be repealed to the extent of such inconsistency.

Referral to Planning Board. A copy of this Ordinance shall be referred to the Planning Board following its introduction for review pursuant to N.J.S.A. 40A:55D-26A.

WHEREAS the Knock Out Opioid Abuse Day campaign is sponsored by the Partnership for a Drug Free New Jersey in cooperation with the Governor's Council for Alcoholism and Drug Abuse and the NJ Department of Human Services Division of Mental Health and Addiction Services to raise awareness of the potential for dependency on prescribed pain medicine and its link to heroin use rates in our state, reduce stigma of addiction and shine a light on the need for recovery support, and communicate to physicians information on safer prescribing messages found in the Centers for Disease Control and Prevention guidelines for prescribing opioids, which include considering other therapies, setting realistic treatment goals with patients and discussing with patients the positives and negatives of opioids; and WHEREAS, the Township of Middle supports initiatives designed to raise awareness about opioid abuse in

WHEREAS, the Township of Middle supports initiatives designed to raise awareness about opioid abuse in New Jersey and take steps to prevent addiction;

  - (A)WHEREAS, a Contract was awarded, on December 20, 2021, via Resolution No. 525-21 to CNS Cleaning Company for Janitorial Services.

WHEREAS, on December 29, 2006, the New Jersey Council of Affordable Housing approved Middle Township's Development Fee Ordinance which, among other things, permitted the Township to collect residential and nonresidential development fees and to use said fees for purposes of advancing the interests of the region's low- and moderate-income households and associated administrative costs; and

WHEREAS, in December of 2019, the Committee of the Township of Middle, County of Cape, filed an action seeking a judicial declaration that its amended Round 3 Housing Element and Fair Share Plan created the requisite "realistic opportunity" for the construction of its fair share of the regional need for housing affordable to low- and moderate-income housing; and

WHEREAS, on January 27, 2022, the Township and Fair Share Housing Center ("FSHC") executed a Settlement Agreement establishing the Township's Round 3 fair share obligations and presenting a framework of the credits and future compliance mechanisms to be implemented to address Middle's affordable housing obligations; and

WHEREAS, on March 25, 2022, the Court approved the Settlement Agreement by way of duly noticed Mount Laurel Fairness Hearing; and

WHEREAS, N.J.A.C. 5:93-8.9 requires a municipality with an affordable housing trust fund to receive approval of a spending plan prior to spending any of the funds in its housing trust fund; and

WHEREAS, on July 8, 2008, COAH approved Township's Spending Plan; and

WHEREAS, in furtherance of its obligations set forth in the FSHC Settlement Agreement and relevant COAH regulations; the Township intends to endorse an updated Spending Plan, attached hereto.

NOW THEREFORE BE IT RESOLVED that the Committee of the Township of Middle, County of Cape May, hereby endorses the attached updated Spending Plan and requests that the Court review and approve same.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.

26. RESOLUTION 425-22 – AUTHORIZING SURRENDER OF TRI PARTY ALLOCATION CATEGORY AGREEMENT – On motion by Committeeman Gandy seconded by Committeeman Norris and passed on roll call, the following resolution was adopted.

WHEREAS, On or about November 13, 2005, the Township of Middle, entered into a Tri Party Allocation Category Agreement, a copy of which is annexed hereto as Exhibit "A", relative to the development of a certain parcel of land designated as Lots 3.01 and 3.03, Block 4.01 as shown on the current tax map of Middle Township, New Jersey; and

WHEREAS, the Developer therein has failed to complete the project work as contemplated and required; and

WHEREAS, there remains a balance in the Allocation Category in the amount of Forty-Three Thousand Eight Hundred and Ten (\$43,810.00) dollars; and

WHEREAS, representatives of the Developer have agreed that the remaining fund balance can be tendered to the Township in exchange for a release relative to the balance of work to be performed; and WHEREAS, the Township Engineer has determined that the remaining balance in the Allocation Category is sufficient to cover the costs of the remaining work to be performed.


