BE IT ORDAINED by the Township Committee of the Township of Middle in the County of Cape May and the State of New Jersey as follows:

Section 1. Chapter 112 of the Code of the Township of Middle is hereby amended and supplemented to add a new article entitled Construction Surveys to read as follows:

ARTICLE IV – CONSTRUCTION SURVEYS

112-10 DEFINITIONS

As used in this chapter, the following terms shall have the meanings indicated:

CONSTRUCTION

Interpreted to include the construction of any new structure, the renovation of any existing structure and the alteration of any existing structure.

HEIGHT

Building height as that term is defined in those ordinances that have been codified in the Code of the Township of Middle.

STRUCTURE

Structure as that term is defined in those ordinances that have been codified in the Code of the Township of Middle and includes both principle structures and accessory structures.

12-11 Surveys Required at Certain Intervals

During all construction the property owner shall cause to be submitted to the Township of Middle Zoning Official for approval surveys which have been prepared by a New Jersey licensed professional land surveyor at the following intervals:

- A. Upon completion of any new, renovated or altered structure foundation. This survey shall depict the exact location of all structure foundations upon the property, the top of foundation elevations and all setbacks. This survey shall certify that those locations, elevations and setbacks conform with the zoning requirements for the zoning district in which the subject property is located and any approvals that have been granted by the Middle Township Zoning Board of Adjustment or by the Middle Township Planning Board. No framing shall commerce until this survey has been submitted and approved. No inspections shall be scheduled through the Construction Office until this survey has been submitted and approved.
- B. Upon completion of roof framing and sheathing. This survey shall certify that the height of all structures located upon the property and their setbacks conform to the zoning requirements for the zoning district in which the subject property is located and any approvals that have been granted by the Middle Township Zoning Board of Adjustment or by the Middle Township Planning Board. No rough inspections shall be performed by Construction Office Officials until this survey has been submitted and approved.
- C. Before an application for a certificate of occupancy, either temporary or permanent, is completed. This survey shall certify that the height and location of all structures upon the property, as well as all setbacks and the location and dimensions of all sidewalks, driveways, driveway aprons and curb cuts upon the property, conform to the zoning requirements for the zoning district in which the subject property is located and any approvals that have been granted by the Middle Township Zoning Board of Adjustments or by the Middle Township Planning Board. No certificate of occupancy, either temporary or permanent, shall be issued until this survey has been submitted and approved.
- Section 2. All other Ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.
- Section 3. Should any section, paragraph, sentence, clause or phrase of the Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby, and shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable.
- Section 4. This Ordinance shall become effective immediately upon filing with the Cape May County Planning Board and publication of notice of passage.

WHEREAS, Senator Michael L. Testa, Jr. introduced S-3388, urging Governor Murphy to redirect \$300 million in certain federal funds under FY 2023 appropriations act to create a competitive capital project grant program in the Office of Secretary of Higher Education; and

WHEREAS, the fiscal year 2023 appropriations act includes an overabundance of special appropriations that benefit specifically named public and private organizations and groups; and

WHEREAS, these special, direct appropriations are included in the appropriations act without providing similar organizations and groups across the State the opportunity to earn these public dollars; and WHEREAS, the fiscal year 2023 appropriations act inappropriately authorizes \$300 million in federal funds to be allocated to Rutgers University for undisclosed capital needs while other institutions of higher education and postsecondary schools throughout the State have legitimate infrastructure needs that have been ignored; and

WHEREAS, these federal funds can be more fairly and efficiently allocated if the State makes them available to all institutions of higher education and other postsecondary schools on a competitive basis, which recognizes the needs of all of these educational entities and seeks regional balance in the distribution of monies; and

WHEREAS, It is altogether fitting and proper that the State redirect the \$300 million currently available only to Rutgers University for its capital needs, to create a competitive grant program that can make monies available to all institutions of higher education in the State.

NOW, THEREFORE, BE IT RESOLVED, that the Township Committee, of the Township of Middle, County of Cape May and State of New Jersey, strongly supports Senate Bill 3388 and is hopeful that the Governor will consider reallocating these funds to a competitive, merit-based process that is open to the broader education community

WHEREAS, the bills (A646/S2079) would increase the allocation of revenues from the hotel and motel occupancy fee towards arts, historical heritage, and tourism purposes from 40 percent to 100 percent; and WHEREAS, the change in allocation would assure that counties like Cape May, Ocean, Monmouth, and Atlantic would retain more of their contributed tourism dollars, and in essence, could be used to improve infrastructure critical to attract more patrons and tourists along the Jersey Shore; and

WHEREAS, in Cape May County, for example, hotel and occupancy taxes raised nearly \$16.3 million in 2021 but the county only received \$1.05 million back in Fiscal Year 2022 Arts and History Grants. By comparison, Essex County only generated about \$4.2 million in the same taxes but received \$8 million in grants funding according to figures from the state Department of Treasury.

NOW, THEREFORE, BE IT RESOLVED, that the Township Committee, of the Township of Middle, County of Cape May, and State of New Jersey, strongly supports Senate Bill 2079 and Assembly Bill 2079 and requests the Governor's passage of the same.
