The Township Committee met on the above date at 6:00 PM at the Middle Township Municipal Building. Members present were Mayor Donohue, Deputy Mayor Gandy, Committeemember Norris, Township Clerk/Business Administrator Kimberly Osmundsen, Deputy Township Clerk Emily Bartleson, Deputy Business Administrator Suzanne Schumann, Township Engineer Vince Orlando, & Municipal Solicitor Rick DeMichele

1. QUESTION/ANSWER PERIOD ON AGENDA (This question-and-answer session shall relate only to items as outlined and pending on current agenda. Issues and concerns not related to agenda item shall be withheld to public comment portion at the conclusion of meeting.)

Mary Ann Alulis, CMCH, asked about special events coordinator title.

Mayor Donohue described the responsibility of the position.

Stan Doniger, Rio Grande, discussed appreciation on the job done by the Township maintaining the budget throughout the years. Asked about the tax raise for this year.

Mayor Donohue advised that this information would be explained during the budget presentation later in the meeting.

Stan Doniger, Rio Grande, asked about decision to enter into agreement with Inspira and County Dispatch services and what effects these decisions had on the budget.

Mayor Donohue explained how the costs typically used for these services were distributed. The purpose of entering into the EMS contract was not to save money but to assist in providing the residents of Middle Township with the best and most sustainable EMS service they could. He explained that the benefits of switching to County Dispatch and they millions of dollars in costs the Township would have faced to bring in house dispatch services up to State requirements. Further explained that in addition to these factors, the Township was having difficulty finding dispatchers as well as EMS personnel.

John Lauricella, Cape May Court House, asked if there had been any help from the State to help offset healthcare costs for municipalities.

Mayor Donohue discussed minimal assistance provided.

Wanda Matthews, Whitesboro, asked about agenda item 19 and if the properties listed would be the properties sold. In addition, if the properties would be public housing.

Kimberly Osmundsen explained that the list with the resolution was the properties being sold with an exception of 613 Cedar Avenue, which was being removed and would be relisted in a future land sale. She stated the properties on the list were Township owned land parcels not public housing.

ORDINANCE 1669-23 - AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14) - On motion by Committeeman Gandy seconded by Committeeman Norris and passed on roll call, Ordinance No. 1669-23 passed first reading. Second reading, public hearing and consideration for adoption will be held on 05/01/2023 at 6:00 p.m.

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Middle in the County of Cape May finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$218,177.19 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.
