Complete Ordinance is on file in the Clerk's Office.

WHEREAS, on November 3, 2020, more than two-thirds of the registered voters in New Jersey voted to approve Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults 21 years of age and older; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act", N.J.S.A. 24:6I-31, et seq. (the "Act"), which legalized the recreational use of marijuana by adults 21 years of age or older; and

WHEREAS, the Act establishes a comprehensive regulatory and licensing scheme for commercial, recreational (adult use) cannabis operations, use, and possession; and

WHEREAS, on October 18, 2021, pursuant to the provisions of N.J.S.A. 24:6I-45, the Mayor and Township Committee ("Township Committee") of the Township of Middle ("Township") adopted Ordinance No. 1635-21 authorizing certain marketplace classes of licensed cannabis businesses within the Township of Middle, subject to the applicant's receipt of all applicable planning, zoning, and other local and state regulatory permits and approvals; and

WHEREAS, the Township Committee is empowered to adopt an ordinance to regulate buildings and structures, and their use and occupancy, and to prevent and abate conditions detrimental to the health safety, and welfare of the general public pursuant to N.J.S.A. 40:48-2.12a and N.J.S.A. 40:48-2.12f; and WHEREAS, the Township Committee is empowered to adopt an ordinance to provide for the inspection of buildings to assure the health, safety, and public welfare of the municipality and its residents pursuant to N.J.S.A. 40:48-2.12a1; and

WHEREAS, on September 6, 2023, by way of Ordinance No. 1676-23, the Township amended Chapter 106, "Cannabis", of the Township Code to provide for local licensure of permitted cannabis facilities; and WHEREAS, Section 106-4(D) of the Township Code prohibited licensed cannabis establishments from operating within 1,000 feet of any public or private school, including elementary, vocational, or secondary schools, colleges, and universities; a state-licensed childcare center; a house of worship; and a state-licensed addiction recovery facility as measured from the boundary of each parcel; and

WHEREAS, the Township Committee finds that the measurement of 1,000 feet from each parcel's boundaries is overly burdensome and desires to restructure the measurement to be from main front entrance door to main front entrance door; and

WHEREAS, Section 106-5(E)(2) of the Township Code requires an applicant for a local letter to support to obtain a state license within one (1) year from the date of issuance of the Resolution of Local Support; and WHEREAS, the Township Committee finds that Section 106-5(E)(2) requires clarification such that an applicant is required to obtain its annual state license to avoid forfeiture of its Resolution of Local Support; and

WHEREAS, the Township Committee finds that it is in the best interest of the Township to make the above-referenced revisions to Chapter 106 that result in a more practical application of its terms. NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of Middle, County of Cape May, State of New Jersey:

Section 1. That the aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Section 106-4(D) of the Township of Middle Municipal Code shall be deleted and replaced, in its entirety, with the following: §106-4

D. No authorized and approved License Class(es) establishment shall be located within a distance of one thousand feet (1,000 ft.) as measured from the main front door entrance to the main front door entrance of any building on which the following land uses are located: a public or private school, including elementary, vocational, or secondary schools, colleges, and universities; a state-licensed childcare center; a house of worship; and a state-licensed addiction recovery facility. In the event the Licensed Class establishment contains more than one (1) building on its property, the distance shall be measured from the building closest to the land use(s) cited herein.

Section 3. Section 106-5(E) of the Township of Middle Municipal Code shall be deleted and replaced, in its entirety, with the following: \$106-5

- E. Expiration of Resolution of Local Support. All Resolutions of Local Support shall expire one (1) year from the date of issuance unless:
 - 1. The Township has, by resolution, extended the expiration date of the Resolution of Local Support; or
 - 2. The applicant has received an annual state license.

<u>Section 4.</u> All other Chapters of the Township Code not amended by this Ordinance shall remain valid and in full force and effect and are not amended by this Ordinance.

<u>Section 5.</u> All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

<u>Section 6.</u> Should any section, clause, sentence, phrase, or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

<u>Section 7.</u> This Ordinance shall take effect after final passage, approval, and publication, as provided by law.

Kimberly Osmundsen advised that cannabis attorney, James Maley, was in attendance for ordinance review.

Mayor Leusner invited Mr. Maley to discuss the ordinance changes.

James Maley, Township's Cannabis Attorney, explained there was unclarity in the ordinance regarding distance requirements and this amendment clarified that the 1,000 ft requirement is specific to door to door.

Mayor Leusner explained that there has been inquiries regarding a second license and clarified that the Township is currently on pause with issuing any additional license at this time while INSA is established and beginning operations and the Township has time to assess how this new business affects the Township.

Nancy Wheeler Driscoll, Swainton, discussed her work with children and the efforts put in to emphasize the impact of drugs to them. She further discussed normalizing the gateway drug that is marijuana and presented Committee with various statistic reports she pulled regarding marijuana use in Cape May County. She continued to discuss her concerns with changing the language to door-to-door in relation to the proximity this could allow these businesses to have to a school and suggested changing the language instead to a radius of 1,000 ft. She then continued to discuss her concerns with the legalization of marijuana.

Mayor Leusner explained the governing body had begun to discuss this topic in 2018 in regards to medical marijuana. He explained when he was Chief of Police he was against the legalization; however it was passed by over 70% of voters in New Jersey. The Township has had many public discussions on this topic. He further explained that there are already a number of dispensaries surrounding the Township that other municipalities have approved and that the Governing Body's thought process through the entire process has been that if they are going to have these types of businesses impacting this community than they want to be sure to have as much oversight as possible. He is confident in this company coming to Swainton and that they will not have a negative impact on the community.

Mayor Leusner continued to discuss the various factors effecting these decisions by the Township. He expressed that it is important to proceed cautiously with this process, which is why the Township is on a hold for the second license.

Mayor Leusner asked James Maley about the concerns with the door-to-door clarification.

James Maley, Cannabis Attorney, clarified that it is 1,000 ft from entrance to entrance.

Kimberly Osmundsen asked Mr. Maley to explained how the application process affects licensing.

James Maley, Cannabis Attorney, explained that the Township has control through their licensing process which reviews components such as location. He advised that all applications must go through this review process before they can be licensed in the Township and also have to go through a site plan process as well.

Mayor Leusner further explained that there are numerous steps before a company can be opened.

David Lerman, 301 N. Main LLC, advised he is the owner of the property located on the corner of Route 9 and Court House South Dennis Road. He explained that he was approached by a cannabis company to purchase his property but they company was confused by the 1,000 ft requirement. He further explained that his property is within distance to the child care center at the hospital which would prohibit the company from opening at his location. He requested that the Township further clarify the language for the distance to be measured from walking or driving distance versus as the crow flies or that the Township consider reducing the distance to 900 ft.. He submitted a memo to Township Committee with suggested language for the ordinance to include these changes.

Kelly Cunningham, 6 Beaver Damn Rd, expressed concern with having a cannabis business close to her home. She continued to discuss concerns with a cannabis business being allowed within a 1,000 ft radius to a school.
