6. ORDINANCE 1698-24 – AN ORDINANCE OF THE TOWNSHIP OF MIDDLE, COUNTY OF CAPE MAY, STATE OF NEW JERSEY AMENDING CHAPTER 66 OF THE TOWNSHIP CODE, CREATING THE MIDDLE TOWNSHIP GARDEN CLUB – On motion by Committeeman Gandy seconded by Committeeman Norris and passed on roll call, Ordinance No. 1698-24 passed first reading. Second reading, public hearing and consideration for adoption will be held on 05/20/2024 at 6:00 p.m.

BE IT ORDAINED by the Township Committee of the Township of Middle in the County of Cape May and State of New Jersey as follows:

WHEREAS, the Township Committee of the Township of Middle does hereby wish to establish the Middle Township Garden Club (hereinafter referred to as the "MTGC") for the purposes of developing ideas, researching costs, and implementing approved plans for beautification projects and events.

WHEREAS, the Township Committee desires to formalize the nature of the Garden Club to enable it to more efficiently fulfill its mission.

THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Middle in the County of Cape May and State of New Jersey as follows:

<u>SECTION 1</u>: Chapter 66 of the Municipal Code of the Township of Middle if hereby amended and supplemented as follows:

§ 66-13 Garden Club.

A. ESTABLISHMENT AND PURPOSE

1) This hereby creates the "Middle Township Garden Club" which is dedicated to supporting recreational community gardening. The MTGC fosters community pride and promotes community partnership towards the beautification of municipally and privately-owned properties within the municipal borders.

B. ESTABLISHMENT OF MEMBERSHIP

1) This Club shall consist of unlimited members of the Township of Middle who desire to get involved in the various established events of the Garden Club.

C. OFFICERS; TERMS AND ORGANIZATION

- 1) The Middle Township Garden Club shall meet immediately after January 1 of each year for the purpose of reorganization. The agenda at this meeting should include the establishment of dates and places of meetings and such other business as may properly come before the Club at the annual reorganization meeting. The Club shall meet as often as determined by the Club, as the need for said meetings is presented.
- 2) The Governing Body shall name and select a Chairperson and a Vice Chairperson of the MTGC Committee for a term of service of one (1) year. In the absence of the Chairperson, the powers and duties of the Chairperson shall be performed and exercised by the Vice Chairperson.
- 3) Three (3) additional MTGC Committee members shall be appointed for a term of one (1) year.
- 4) The MTGC Committee members may serve for successive years if reappointed by the Township Committee. In the event of a vacancy occurring on the MTGC Committee other than by expiration of a term, such vacancy shall be filled by the Township Committee for the unexpired term.
- 5) On behalf of the Club, the Township shall appoint a staff member as secretary to the club and provide legal counsel from the municipal solicitor if needed.

D. COMPENSATION

1) The members of the Committee shall serve without compensation.

E. POWERS AND DUTIES

- 1) With the advice and consent of the Township Committee, the Middle Township Garden Club may be granted the following powers and duties in discharging its intent and purpose:
 - a) The Middle Township Garden Club may be empowered to advertise, prepare, print and distribute pamphlets, brochures, maps, books or other reading material which are necessary for the promotion of any programs, projects or activities under its authority.
 - b) The Middle Township Garden Club shall have the power to appoint subcommittees of the general citizenry in specific areas and for specific beautification projects.
 - c) The Middle Township Garden Club shall keep records of its meetings and activities and shall file an annual report of its activities and budgetary expenditures with the Township Committee on or before December 31 of every calendar year.
 - d) In cooperation with the Township Administration, the Middle Township Garden Club may apply for any state, federal and private grants for the purpose of beautification projects within the Township.

F. FUNDING, DEPOSITING, AND EXPENDITURE OF FUNDS.

- 1) The Township Committee may appropriate such sum in each year's current fund budget as may be determined by the governing body to be necessary for the purpose of the Middle Township Garden Club.
- 2) Should the MTGC receive any gifts, donations or bequests, such funds shall be deposited in a trust fund account established by the Township's Finance Department and shall not be utilized for any horticulture or landscaping projects without the prior approval of the Township Committee. Dedicated funds shall be spent for the purpose for which the funds were received, in accordance with the Local Budget Law, N.J.S.A. 40A:4-1 et seq. The MTGC shall require any individual or entity donating services and/or capital improvements to the Township to supply to the Township an indemnification and hold harmless agreement prior to the commencement of any such donative efforts as may be required by the municipal joint insurance fund.

<u>SECTION 2</u>: Any other Ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

<u>SECTION 3</u>: Should any section, paragraph, sentence or clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected

thereby and shall remain in full force and effect and to this end the provisions of this Ordinance are hereby declared to be severable.

<u>SECTION 4</u>: This Ordinance shall become effective immediately upon final passage and publication, according to law.

Mayor Leusner discussed excitement of this new club to help with the beautification throughout the Township.

 - 54-3 Membership.
 - A. The Recreation Advisory Council membership shall consist as follows:
 - (1) Seven (7) members at large.
 - (2) One (1) member of the recreation department
 - (3) One (1) Township Committee liaison
 - The initial appointees to the board shall serve terms as follows:
 - (1) Three members: three-year term.
 - (2) Three members: two-year term.
 - (3) One member: one-year term.
 - Thereafter, all subsequent or reappointed members shall serve a term of three years commencing January 1.

 B. The Council shall retain the services of a secretary appointed by the governing body, who shall keep the minutes of the meetings and provide such clerical services as may be required by the Council.
 - C. The members of the Council shall serve without compensation.
 - <u>D.</u> The Council will meet at least every quarter, or on such other more frequent meeting dates as the agenda established by the Committee shall provide.

SECTION 2. All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency.

SECTION 3. Should any section, paragraph, sentence, clause or phase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be serverable.

SECTION 4. This Ordinance shall become effective immediately upon final passage and publication, according to law.

Committeeman Norris explained the purpose of this revision is to clean up the ordinance and the difficulty they are having with membership as it currently stands.

Kimberly Osmundsen further explained purpose of changing membership to "members at large".

WHEREAS, prior Resolution 203-23 adopted on April 17, 2023 by the Mayor and Township Committee authorizing the Planning Board to conduct a preliminary investigation to establish a condemnation redevelopment area for a similar Study Area is hereby rescinded in its entirety.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Middle, County of Cape May, State of New Jersey as follows:

22. PUBLIC COMMENT:

John Lauricella, Cape May Court House, spoke of excitement regarding the Police Department promotions.

David Robinson, Cape May Court House, requested a traffic survey on Route 9 between Shell Bay and Johnstown Lane due to the residents and businesses in the area and the current speed allowance on the road. He continued on the discuss the accidents in the area. He requested that double yellow lines be added to the area, the speed limit be reduced to 25mph, the area become a no jake break zone and that sidewalk and curbing be added to the area as well.

David Robinson, Cape May Court House, then asked for a new homeless policy on the relocation of homeless individuals. He stated that he heard if there is a section 8 housing anywhere in the State that it can go to a homeless individual for housing but if they refuse than they can be placed under arrest.

Mayor Leusner discussed an article formally put out regarding homeless policies in Middle Township that reference an "Idaho Model" which the Township did not adopt. He then explained the partnership the Township has with Volunteers of America (VOA) which helps in assisting homeless individuals to seek housing however they are not utilized to track down individuals to lock up but to provide assistance and resources to these individuals to provide different options to help them and try to get them on a better path. He reiterated that VOA has been amazing in assisting individuals and he is upset that the State may take away the funding that allows for this partnership.

David Robinson, Cape May Court House, stated he was in agreeance with the Idaho model and supports requiring people to obtain housing.

Mayor Leusner reiterated need for the VOA and the assistance they provide.

David Robinson, Cape May Court House, asked about business registration requirement.

Mayor Leusner explained concerns from business owners regarding enforcement to revoke a business' license. He further explained the Township will not utilize the requirement to revoke the "license".

Matt Rooney used dog licenses as a reference to a similar registration requirement.

David Robinson, Cape May Court House, discussed required fee and frustration of him having to complete the application and upload documents and being charged the fee. He stated he believes the fee is unreasonable.

Mayor Leusner explained the process is more than just "hitting a button". He advised the requirement takes new software, employees time and more and that most other municipalities have had a business license requirement for many years at much larger costs. The stated that the Governing Body believes the \$75.00 fee was reasonable compared to other towns especially considering what the process requires. He further reiterated that this registration is due to requirements through the State.

Vince Conte, Cape May Court House, asked about advantage that condemnation has on the development designation investigation.

James Maley explained there have been various reasons as to why many of these properties have not been utilized, such as owners who are no longer there anymore. He further explained different instances where eminent domain comes in beneficial.

Vince Conte, Acorn Lane, asked how the community is protected during the eminent domain process.

James Maley explained the eminent domain process is very extensive and further explained the process. He stated the statutory amendments done years ago require the Township to establish these areas early in the process to provide availability for it to be challenged and proven a property is not in need of redevelopment.

Mayor Leusner explained that 99% of the properties in the redevelopment area are commercial properties. He then discussed establishment process of determining their areas.

James Pennington, Rio Grande, asked if it was necessary to utilize eminent domain if these properties are tax delinquent.

James Maley explained difference between in-rem foreclosure and condemnation redevelopment.

David Robinson, Cape May Court House, explained concerns about Matthews Avenue and flooding.

Kimberly Osmundsen advised that they are reviewing drainage of that area.

Wanda Shepherd, Whitesboro, asked for a traffic review at Main Street and Route 9 intersection in Whitesboro.

Mayor Leusner asked what her concerns are for that areas.

Wanda Shepherd, Whitesboro, stated concerns that it is narrow, people making left turns and the length of the light. She also requested speed bums on George Street like there is on Main Street.

Kimberly Osmundsen explained the only reason for the speed bumps on Main Street is the recreation center.

Wanda Shepherd, Whitesboro, asked about Goshen Road paving.

Mayor Leusner stated the road is scheduled to be paved by the County by fall of the following year.

COMMITTEE COMMENTS:

Committeeman Gandy congratulated Katrina. He stated she was a great asset to the Construction Department. Advised that Shred Day would be held on May 4th as well as the Rabies Clinic. He explained that they were still looking for donations for the Drum Fish Tournament. He then advised that he is looking forward to the establishment of the Garden Club. He lastly recognized all the officers being promoted and congratulated them all.

Committeeman Norris recognized John Oliva, of Public Works, son on his 100th career strikeout and how great of an achievement that was. He then discussed opening day of little league and recognized the association, parents, coaches and staff for their hard work. He continued on to speak of a post shared by the Garden Club seeking donations and volunteers for a project at the American Legion and encouraged residents to speak with the club. Next he thanked Silvia Lockwood that works on the Environmental Commission and worked their booth at the Earth Day celebration at the zoo as well as the Police Officers that worked the event as well. Lastly, he reiterated that they are still seeking donations for the Drum Fish Tournament.

Mayor Leusner discussed throwing the first pitch to his son during the little league opening day. He then discussed the Earth Day event at the zoo and the Arts and Music Festival held at Kindle.

He echoed the comments made on the promotions made within the Police Department. He invited the public to attend the swearing in of the officers on May 1^{st} at 3:30 at the Senior Center.
